SUMMARY:
Ordinance 19550 enacts for one year a moratorium prohibiting the acceptance of applications for the establishment of new or expansion of existing wineries, breweries, distilleries and remote tasting rooms, as primary or accessory uses or as home occupations or home industries; and prohibiting temporary use permits for wineries, breweries, distilleries and remote tasting room. It also establishes a work plan to evaluate the next steps for the regulations regarding winery, brewery, distillery and related uses.
