NOTICE IS HEREBY GIVEN that the Metropolitan King County Council will hold a public hearing in the King County Countil Chambers, 10th Floor, King County Courthouse, 516 3rd Avenue Room 1001, Seattle, Washington, on Tuesday November 15, 2022 at 1:00 p.m. Remote public testimony on Zoom will also be accepted. The purpose of this hearing is to consider adoption of Proposed Ordinance No. 2022-0377, which would update King County Code Chapter 9.08 to amend fees that are charged to property owners within its surface water management service area, which is unincorporated King County, to minimize the impacts of storm and surface runoff on the water quantity and quality of the waters of the state.

King County works in partnership with property owners and state and federal agencies to minimize the impacts of storm and surface runoff on the water quantity and quality of the waters of the state. King County charges property owners within its surface water management service area, which is unincorporated King County, a graduated fee based on six nonresidential rate classes tied to relative amount of impervious surface and one uniform rate class for all residential parcels. Proposed Ordinance No. 2022-0377 would update King Count Code Chapter 9.08 and revise the graduated fees as follows:

Class, Impervious Surface %, Current Rate, Proposed Rate
Residential, N/A, \$289.00, \$323.00
Very Light, 0% to less than or equal to 10%, \$289.00, \$323.00
Light, Greater than 10% to less than or equal to 20%, \$803.51, \$98.04
Moderate, Greater than 20% to less than or equal to 45%, \$1,504.04, \$1,680.99
Moderately Heavy, Greater than 45% to less than or equal to 65%, \$2,566.60, \$2,868.55
Heavy, Greater than 65% to less than or equal to 85%, \$3,575.37, \$3,996.00
Very Heavy, Greater than 35% to less than or equal to 100%, \$4,399.10, \$4,916,64
Minimum charge in any class \$289.00, \$323.00
Mobile home parks' maximum annual service charge \$289.00, \$323.00
