NOTICE IS HEREBY GIVEN, that a public hearing before the Metropolitan King County Council will be held at the King County Courthouse, 516 3rd Avenue Room 1001 on the 27th day of June, 2023, at 1:30 p.m. to receive public testimony related to Ordinance 19613. Remote public testimony on Zoom will also be accepted. ### STATE OF WASHINGTON, COUNTIES OF KING AND SNOHOMISH

The undersigned, on oath states that he/she is an authorized representative of The Seattle Times Company, publisher of The Seattle Times of general circulation published daily in King and Snohomish Counties, State of Washington. The Seattle Times has been approved as a legal newspaper by orders of the Superior Court of King and Snohomish Counties.

Ordinance 19613 adopted a seven-month moratorium prohibiting subdivisions of residentially zoned land in the Rural Town of Fall City, findings in support of the moratorium, and requirements for a study to address the issues and circumstances necessitating the moratorium. No action is planned after the public hearing.

Ordinance 19613 was adopted on May 16, 2023. A public hearing within sixty days of the enactment of a moratorium is required by RCW 36.70A.390. This hearing is an opportunity for public testimony of the moratorium.

The notice, in the exact form annexed, was published in the regular and entire issue of said paper or papers and distributed to its subscribers during all of the said period.
