

PRELIMINARY REPORT:

On April 6, 2023, the Department of Natural Resources and Parks (DNRP) submitted its report on file no. E22CT024 to the Examiner.

PUBLIC HEARING:

After reviewing the preliminary report and examining available information on file with the application, the Examiner conducted a remote public hearing on the application on April 20, 2023.

Participants at the public hearing and the exhibits offered and entered are listed in the attached minutes. A verbatim recording of the hearing is available in the Hearing Examiner's Office.

FINDINGS AND CONCLUSIONS:

1. General Information:

2. The Applicants timely filed an application to King County for the Public Benefit Rating System (PBRS) program current use valuation of the property to begin in 2023. As required by law, notification of the application occurred.

3. A summary of relevant PBRS categories follows below. (Plain text represents a category an applicant requested an award for and that DNRP agrees is warranted. Any ~~strike through~~ represents a category an applicant requested an award for but that DNRP disagrees is warranted. Any *italics* represents a category an applicant did not request an award for, but that DNRP nonetheless concludes is warranted. And any *asterisk* represents a category where DNRP finds an award is warranted, but only if certain contingencies or conditions are met.)

The DNRP-recommended score of 13 points results in a current use valuation of 40% of assessed value for the enrolled portion of the property.

4. Additional credit may be awarded administratively under the forest stewardship land category, subject to submittal of a forest stewardship plan by **October 31, 2023**, and subsequent DNRP approval of that plan by **December 31, 2023**. Award of credit under this category will increase the point total by five points and may allow approved forestry activities to occur on the property.
5. There is also a Type F stream and likely a forested wetland, though determining the category/class/boundaries of the wetland requires professional evaluation. If, by **December 1, 2023**, the Applicants submit a map and report detailing the location and types of aquatic features, and DNRP can determine by **December 31, 2023**, that the Applicants are providing a buffer of native vegetation that is:
 - A. At least 15% greater than the regulatorily-required buffer, then five points can be administratively awarded under the significant wildlife or salmonid habitat category; and/or
 - B. At least 1.5x (five points) 2x (eight points) or 3x (ten points) the regulatorily-required buffer, then those points can be administratively awarded under the surface water quality buffer category.
6. Thus, the Applicants have the opportunity to earn anywhere between 5–20 additional points. Five additional points would result in a current use valuation of 30% of assessed value for the enrolled portion of the property, while eight or more points would result in a current use valuation of 20% of assessed value for the enrolled portion of the property.
7. As to the land area recommended for PBRS enrollment, the Applicant requested 6.00 acres and DNRP recommends 6.20 acres. (Enrollment acreage is the entire parcel less the excluded area, as calculated by DNRP. In the event the County Assessor's official parcel size is revised, the PBRS acreage shall be administratively adjusted to reflect that change.)
8. Except as modified herein, we find the facts set forth in DNRP's preliminary report and testimony at the April 20, 2023, public hearing correct and we incorporate them by reference. We will provide copies of this report and DNRP's report to the Metropolitan King County Council for final approval.

9. Approval of 13 points and a current use valuation of 40% of assessed value for 6.20 acres, and conditional approval of up to 20 additional points and 20% of assessed value for those acres, are consistent with KCC Chapter 20.36 and with the purposes and intent of King County to maintain, preserve, conserve, and otherwise continue in existence adequate open space lands and to assure the use and enjoyment of natural resources and scenic beauty for the economic and social well-being of King County and its citizens.

RECOMMENDATION:

1. APPROVE a current use valuation of 40% of assessed value for the 6.20-acre enrolled portion of the property.
2. CONDITIONALLY APPROVE, additional credit for the:
 - A. Forest stewardship land category, subject to submittal of a forest stewardship plan by **October 31, 2023**, and subsequent DNRP approval of that plan by **December 31, 2023**, and/or
 - B. Significant wildlife or salmonid habitat category and/or the surface water quality buffer category, subject to submittal by **December 1, 2023**, or a map and report detailing the location and types of aquatic features, and DNRP confirmation by **December 31, 2023**, that the Applicant is providing significant additional buffer, which could result in a current use valuation of down to 20% of assessed value for the 6.20-acre enrolled portion of the property.

NOTICE OF RIGHT TO APPEAL

A person appeals an Examiner recommendation by following the steps described in KCC 20.22.230, including filing with the Clerk of the Council a sufficient appeal statement and a \$250 appeal fee (check payable to the King County FBOD). Appeal statements may refer only to facts contained in the hearing record; new facts may not be presented on appeal. KCC 20.22.230 also requires that the appellant provide copies of the appeal statement to the Examiner and to any named parties listed on the front page of the Examiner's recommendation.

Prior to the close of business (4:30 p.m.) on *May 29, 2023*, an electronic copy of the appeal statement must be sent to Clerk.Council@kingcounty.gov and a paper copy of the appeal

statement must be delivered to the Clerk of the Council's Office, Room 1200, King County Courthouse, 516 Third Avenue, Seattle, Washington 98104. Prior mailing is not sufficient if actual receipt by the Clerk does not occur within the applicable time period. If the Office of the Clerk is not officially open on the specified closing date, delivery prior to the close of business on the next business day is sufficient to meet the filing requirement.

Unless both a timely and sufficient appeal statement and filing fee are filed by *May 29, 2023*, the Clerk of the Council shall place on the agenda of the next available Council meeting a proposed ordinance implementing the Examiner's recommended action. At that meeting the Council may adopt the Examiner's recommendation, defer action, refer the matter to a Council committee, or remand to the Examiner for further hearing or further consideration.

If a timely and sufficient appeal statement and filing fee are filed by *May 29, 2023*, the Examiner will notify all parties and interested persons and provide information about "next steps."





ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, King County-Department of 02 (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent
