4	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:	
5	SECTION 1. The council is under an obligation by charter to enact rever	nue
6	measures that support the budget appropriation ordinance by December 1, 2011,	for the
7	2012 budget. This ordinance sets the amount of property tax to be collected for	the
8	regular property tax levy, the road district levy, the conservation futures levy and	l the
9	emergency medical services levy. In accordance with RCW 84.55.120, the coun	cil has
10	given proper notice of this ordinance to the public.	
11	SECTION 2. For collection of the property tax levies in 2012, the counc	il hereby

12 authorizes property tax increases over the amounts authorized for collection in 2011 as
