PRELIMINARY REPORT:

On February 14, 2013, DNRP submitted its report on file no. E12CT035 to the Examiner.

PUBLIC HEARING:

After reviewing the preliminary report and examining available information on file with the application, the Examiner conducted a public hearing on the application on February 27, 2013, in the Ginger Conference Room, 12th Floor, Washington. The Examiner continued the hearing administratively for receipt of the affidavit of publication, later received on February 28, 2013, at which time the hearing record closed.

FINDINGS, CONCLUSIONS, AND RECOMMENDATION: Having reviewed the record in this matter, the Examiner now makes and enters the following:

- 2. The Applicants timely filed an application to King County for timber land current use valuation of the property to begin in 2014. As required by law, notification of the application occurred.
- Except as modified herein, the facts set forth in the DNRP preliminary report and 3. testimony at the February 27, 2013, public hearing are found to be correct and are incorporated herein by reference. Copies of this report and the department report will be provided to the King County Council for final approval.

- 4. As to the land area recommended for timber land program enrollment, the Applicant(s) requested 9.16 acres and DNRP recommends 8.65 acres. (Enrollment acreage is the entire parcel less the excluded area, as calculated by DNRP. In the event the County Assessor's official parcel size is revised, the timber land acreage shall be administratively adjusted to reflect that change.)
- 5. Participation in the timber land program is contingent upon submission of a forest stewardship plan by **June 1, 2013**, and approval by **August 1, 2013**. Failure to meet this requirement will preclude the property from enrollment in the timber line program at present.

CONCLUSION

1. The property proposed for current use assessment meets the requirements of King County Code Chapter 20.36.110, and the subject application for current use taxation as timber land should be approved.

RECOMMENDATION:

APPROVE current use taxation, timber land classification for 8.65 acres, CONTINGENT on approval of a forest stewardship plan as noted in finding no. 5 above, and subject to compliance with implementation of the forest stewardship plan and execution of the State of Washington, Department of Revenue, Open Space Taxation agreement form.

NOTICE OF RIGHT TO APPEAL

In order to appeal the recommendation of the Hearing Examiner, written notice of appeal must be filed with the Clerk of the King County Council with a fee of \$250 (check payable to King County Office of Finance) on or before *March 25, 2013*. If a notice of appeal is filed, the original and two copies of a written appeal statement specifying the basis for the appeal and argument in support of the appeal must be filed with the Clerk of the King County Council on or before *April 1, 2013*.

Filing requires actual delivery to the Clerk of the Council's Office, Room 1200, King County Courthouse, 516 Third Avenue, Seattle, Washington 98104, prior to the close of business (4:30)

p.m. on the date due. Prior mailing is not sufficient if actual receipt by the Clerk does not occur within the applicable time period. If the Office of the Clerk is not officially open on the specified closing date, delivery prior to the close of business on the next business day is sufficient to meet the filing requirement.

If a written notice of appeal and filing fee are not filed within 14 calendar days of the date of this report, or if a written appeal statement and argument are not filed within 21 calendar days of the date of this report, the Clerk of the Council shall place a proposed ordinance that implements the Examiner's recommended action on the agenda of the next available Council meeting. At that meeting the Council may adopt the Examiner's recommendation, defer action, refer the matter to a Council committee, or remand to the Examiner for further hearing or further consideration.

Action of the Council Final. The action of the Council on a recommendation of the Examiner shall be final and conclusive unless within 21 days from the date of the action an aggrieved party or person applies for a writ of certiorari from Superior Court for the purpose of review of the action taken.
