NOTICE IS HEREBY GIVEN that an application has been filed with the Metropolitan King County Council by the Woodinville Water District to amend the existing sewer system franchise no. 12151, to update the service area. Specifically to include one additional parcel, in council district 3, and authorizing the King County executive to execute the franchise agreement amendment.

A public hearing will be held upon said application before the Metropolitan King County Council in Room 1201, King County Courthouse, Seattle, Washington, on the 2nd day of December, 2013 at 1:30 P.M. The following is a legal description of the areas:

THAT PORTION OF THE WEST HALF OF THE NW QUARTER OF SECTION 30, TOWNSHIP 26 NORTH, RANGE 6 EAST, W.M., IN KING COUNTY, WASHINGTON, LYING SOUTHERLY OF THE NORTHERLY MARGIN OF NE 128TH STREET, TOGETHER WITH THOSE PORTIONS OF TOWNSHIP 26 NORTH, RANGE 5 EAST, W.M., IN KING COUNTY, WASHINGTON, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

THE NE QUARTER OF SECTION 24 EXCEPT THE NE QUARTER THEREOF; AND THE SE QUARTER OF SAID SECTION 24; AND THE EAST HALF OF THE EAST HALF OF THE NE QUARTER OF THE NW QUARTER OF SAID SECTION 24; AND THE NE QUARTER OF SECTION 25; AND THE NORTH HALF OF THE NORTH HALF OF THE NE QUARTER OF THE NW QUARTER OF SAID SECTION 25.

EXCEPT THAT PORTION OF TRACT "A" OF THE PLAT OF SUNRISE TERRACE NO. 2, AS RECORDED IN VOLUME 124 OF PLATS, PAGES 10 AND 11, RECORDS OF KING COUNTY, WASHINGTON, LYING WESTERLY OF LOTS 14 THROUGH 17 INCLUSIVE, OF SAID PLAT; AND THAT PORTION OF THE NW QUARTER OF SAID SECTION 25 LYING SOUTHERLY OF THE NORTHERLY MARGIN OF NE 124TH WAY; AND THAT PORTION OF THE SE QUARTER OF THE NE QUARTER OF SECTION 26 LYING SOUTHERLY OF THE SOUTHERLY MARGIN OF NE 124TH WAY;

ON NE 124TH STREET AND WAY FROM THE SAMMAMISH RIVER CHANNEL TO THE WEST LINE OF THE NW QUARTER OF SAID SECTION 25; ON THAT PORTION OF 172ND AVENUE NE LYING WITHIN THE SW QUARTER OF SAID SECTION 24 AND THAT PORTION LYING WITHIN THE NW QUARTER OF SAID SECTION 25 NOT PREVIOUSLY DESCRIBED.
