1           AN ORDINANCE approving a new sewer franchise for the  
2           Lake Washington school district in council district three.

3           STATEMENT OF FACTS:

4           1. The Lake Washington school district filed an application for a new  
5           sewer franchise to operate and maintain an exclusive, tightline sewer  
6           pipeline connecting Wilder Elementary School to the city of Redmond's  
7           sewer system, in council district three.

8           2. The King County council approved the city of Redmond's  
9           comprehensive sewer plan amendment, in Ordinance 16578, pursuant to  
10          the recommendation of the King County utilities technical review  
11          committee.

12          3. The utilities technical review committee has approved the Lake  
13          Washington school district's franchise application as meeting the  
14          requirements of K.C.C. 6.27.060 and 13.24.010.

15          BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

16          SECTION 1. The King County council, having determined that the Lake  
17          Washington school district's application meets the criteria for the granting of a sewer  
18          franchise and that said granting is in the best interests of the public, does hereby approve  
19          the franchise agreement set out in Attachment A to this ordinance and authorizes the

20 King County executive to execute the same in substantially the same form as Attachment  
21 A to this ordinance.


22 SECTION 2. If within forty five days after the granting of this franchise  
23 amendment agreement, the applicant shall have failed to sign the written acceptance

24 incorporated herein, then the rights and privileges granted herein shall be forfeited and  
25 said franchise shall be null and void.


