To whom it may concern,

My name is Amir Islam.

I currently serve as board member on the Squire Park Community Council, and long-term Seattle native. I have lived in the Central District of Seattle all 34 years of my life, and have wittiness the dramatic impact/change in my/our communities development. This community has been largely gentrified, and most of the people who have once lived here have been pushed out to other area's largely due to rising demands in housing, and unsustainable employment that horrifically plague this demographic.

I previously worked for the Urban League Of Metropolitan Seattle as a Gang Intervention, and Prevention Specialist - As well as a Outreach Coordinator. Part of my Job responsibility while there was to get low income families of color and young people jobs, training and housing. I'm familiar with this demographic of people that E.O.E.P initiative would serve - so much so, most people in these community's know me by first name.

They remember the help that I was able to provide by working with CDC's like ULMS, and other government agency's such as the "City of Seattle's Summer Youth Employment Program" where we personally recruited hundreds of youth of color (mostly at-risk youth). At that time I also worked with the world renowned "World Vision" where I was a trainer for the Youth Empowerment Program. Here youth from our inner-city's in Seattle, and across the nation - who are largely impacted by economic, and systematic crisis like low income housing, youth violence, gang and drug infested communities - gathered, and went on to our nations capitol to present their recommendations to our states representation there on Capitol Hill.

I know how to listen to the needs of the communities, build trust, advocate for them, and work with Government with diplomacy. I feel this is one of the most needed skills that will help make the transitions of change that we all want - effectively. Right now that is what the community out cry has been regarding this very sensitive project that the community, and the county is engaged in. We need to find way's to empower our communities - this is one of them.

We have a chance to give local people jobs, training, and services for this project, and hopefully some of these people will go to buy homes in this neighborhood, and become more self reliant, and empowered. I have been asked by Council member Rod Dembowski to serve on this board, and I now am asking you to honor that request. Let's continue to work together building, and bridging the pipe line to sustainable, healthy and empowered community's here in our beloved county.
