## AMENDMENT TO THE MANAGEMENT AND OPERATIONS CONTRACT BETWEEN THE HARBORVIEW MEDICAL CENTER BOARD OF TRUSTEES AND THE UNIVERSITY OF WASHINGTON

WHEREAS, pursuant to RCW 36.62.290, the Harborview Medical Center Board of Trustees (the "Board"), with the approval of the King County Council, entered into that certain Management and Operations Contract, dated December 19, 1995 (the "Contract") with the Board of Regents of the University of Washington (the "Regents") for the management and operation of Harborview Medical Center (the "Medical Center"); and

WHEREAS, the Contract expires on June 30, 2015; and

WHEREAS, the parties have entered into negotiations for a new management and clinical services agreement (the "Agreement") for the operation of the Medical Center; and

WHEREAS, the parties expect such negotiations, and approval process, to extend beyond June 30, 2015, but to conclude no later than January 1, 2016; and

WHEREAS, the parties wish to extend the term of the Contract through the date on which a new Agreement is effective or December 31, 2015, whichever is earlier, to allow for the continuity of the management and operation of the Medical Center;

NOW THEREFORE, for and in consideration of the mutual benefits hereunder and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Board and the Regents agree as follows:

1. Section B of the Contract is hereby amended to read as follows:

This contract is to become effective on July 1, 1995, and shall continue in force until the earlier of December 31, 2015, or the effective date of a new agreement between the parties for the provision of hospital services at the Medical Center.
