1 AN ORDINANCE revising the legal description of the
2 annexation of approximately 0.29 acres of land into fire district
3 27, known as Harkleroad Annexation, for the purpose of

6 STATEMENT OF FACTS:

7 1. Ordinance 18042 relating to the annexation of approximately 0.29 acres of
8 land into fire district 27, known as Harkleroad Annexation, for the purpose of
9 providing fire suppression and emergency medical services, was adopted by the
10 council on May 18, 2015, and approved by the executive on May 27, 2015.

11 2. Ordinance 18042 contained an incorrect legal description of the annexation
12 area.

13 3. On June 2, 2015, a corrected legal description from the Washington state
14 Boundary Review Board for King County was received by the clerk of the
15 council.

16 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

17 SECTION 1. Ordinance 18042, Section 1, is hereby amended to read as
18 follows:


19 The annexation of approximately 0.29 acres of land into fire district 27,
