The proposed WID will prepare plans for watershed improvements including projects that improve drainage of agricultural lands, reduce flooding, help to improve instream flows, promote efficient irrigation water management practices and enhance water quality and fish habitat.

The number of directors desired for the administration of the affairs of the WID shall be 5. The District shall be known and designated as the Snoqualmie Valley Watershed Improvement District.

Purpose of the District

The purposes of the WID shall be for developing water supply options for agricultural landowners; implementing water quality protection measures; improving drainage and other conditions that limit the uses of land for agricultural purposes. The WID shall also act on behalf of landowners to provide cooperative watershed management functions as authorized by RCW 87.03.019 and RCW 39.34.210, which establish the authority for the WID to participate in actions and agreements for the purposes of water supply, water quality, and water resource and habitat protection and management.




Vicinity Map: Snoqualmie Valley Watershed Improvement District
