7	This ordinance sets the amount of property tax to be collected for the regular prope	rty			
8	tax levy, the road district levy, the conservation futures levy, the emergency medic	al			
9	services levy and the ferry district. In accordance with RCW 84.55.120, the counc	il has			
10	given proper notice of this ordinance to the public.				
11	SECTION 2. For collection of the property tax levies in 2016, the council hereby				
12	authorizes property tax changes compared to the amounts authorized for collection in 2015	as
