1 AN ORDINANCE relating to cultural development
2 authority proviso requirements; and amending the
3 2015/2016 Budget Ordinance, Ordinance 17941, Sections
4 74 and 74, as amended.

5 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

6 SECTION 1. Ordinance 17941, Section 74, as amended, is hereby amended to
7 read as follows:

8 CULTURAL DEVELOPMENT AUTHORITY - From the arts and cultural
9 development fund there is hereby appropriated to:

10 Cultural development authority ~~\$(57,597,000)~~ 55,597,000

11 SECTION 2. The council directs that section 1 of this ordinance takes effect
12 before section 3 of this ordinance.

13 SECTION 3. Ordinance 17941, Section 74, as amended, and as amended by
14 section 1 of this ordinance, is hereby amended to read as follows:

15 CULTURAL DEVELOPMENT AUTHORITY - From the arts and cultural
16 development fund there is hereby appropriated to:

17 Cultural development authority ~~\$(55,597,000)~~ 57,597,000

18 P1 PROVIDED THAT:

19 Of this appropriation, \$2,000,000 shall be expended or encumbered solely for the
20 preservation action fund. Of that amount, funds shall not be expended or encumbered
21 until the executive transmits an agreement between the county and 4culture on how the
22 preservation action fund will be administered and governed and an ((~~motion~~)) ordinance
23 that approves the agreement, and the ((~~motion~~)) ordinance is passed by council. The
24 ((~~motion~~)) ordinance shall reference the subject matter, the proviso's ordinance,
25 ordinance section and proviso number in both the title and body of the ((~~motion~~))
26 ordinance. The executive must file the ((~~motion~~)) ordinance required by this proviso by
27 February ((4)) 16, 2016, in the form of a paper original and an electronic copy with the
28 clerk of the council, who shall retain the original and provide an electronic copy to all

29 councilmembers, the council chief of staff, the policy staff director and the lead staff for
30 the budget and fiscal management committee or its successor.
