5	STATEMENT OF FACTS:
6	1. A petition has been filed requesting vacation of that portion of 314th Way
7	Southeast hereinafter described.
8	2. The department of transportation notified the various utilities companies
9	serving the area and was advised that no easements were required within the
10	vacation area.
11	3. The department of transportation records indicates that King County has not
12	maintained 314th Way Southeast. The records indicate that no public funds have
13	been expended for its acquisition.
14	4. The department of transportation considers the subject portion of the right-of-
15	way useless as part of the County road system and believes the public would
16	benefit by the return of this unused area to the public tax rolls

17	5. The right-of-way is classified as "C-Class" and, in accordance with King
18	County Code 14.40.020, the compensation due King County is based on fifty
19	percent of the assessed value of the subject right-of-way which was determined
20	from records of the department of assessments. King County is in receipt of
21	\$7,218.00 from the petitioners.
22	6. The right of way is adjacent to the Burlington Northern Santa Fe Railway
23	Company corridor which has been identified in the King County Trails Plan as a
24	potential future trail corridor and King County desires to retain any potential
25	reversionary interest in the railway corridor which upon abandonment might
26.	adhere to the road right of way.
27	Due notice was given in the manner provided by law and a hearing was held by the
28	office of the hearing examiner on the 28 th day of November, 2000.
29	In consideration of the benefits to be derived from the subject vacation, the council
30	has determined that it is in the best interest of the citizens of King County to grant said
31	petition.
32	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
33	SECTION 1: The council, on the 29th day of January, 2001, hereby vacates and
34	abandons that portion of 314th Way Southeast described as follows:
