1	AN ORDINANCE relating to the removal of
2	approximately 1.2 acres of land from the Sammamish
3	Plateau water and sewer district and annexation into the
4	Northeast Sammamish water and sewer district, known as
5	the RTK Annexation, for the purpose of sewer service.
6	STATEMENT OF FACTS:
7	1. A notice of intention proposing the removal of one parcel of
8	approximately 1.2 acres of land, from the Sammamish Plateau water and
9	sewer district and annexation into the Northeast Sammamish water and
10	sewer district, known as RTK Annexation, for the purpose of providing
11	sewer service was filed with the county council on March 28, 2016.
12	2. The RTK parcel receives water service from the Sammamish Plateau
13	water and sewer district, and will continue to remain in that district for the
14	purpose of water service.
15	3. The Sammamish Plateau water and sewer district does not currently
16	have sewer lines in the area of the RTK parcel. The Northeast
17	Sammamish water and sewer district has a sewer main directly in front of
18	the RTK parcel, and has capacity to service this property.

19	4. The RTK parcel is on the boundary of the two districts' sewer service
20	boundaries.
21	5. The Northeast Sammamish water and sewer district has approved the
22	proposed transfer in Resolution No. 4365, passed on June 16, 2014.
23	6. The Northeast Sammamish water and sewer district filed a
24	determination of nonsignificance on the proposed transfer dated January 6,
25	2016.
26	7. The utilities technical review committee reviewed the Northeast
27	Sammamish water and sewer district's comprehensive plan, and found that
28	plan met the criteria for approval. The county approved the most recent
29	comprehensive plan in 2011, as part of Ordinance 17218.
30	8. The county council held the legally required public hearing and has
31	considered the criteria in RCW 57.02.040.
32	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
33	SECTION 1. The removal of approximately 1.2 acres of land from the
34	Sammamish Plateau water and sewer district and annexation into the Northeast
35	Sammamish water and sewer district for the purpose of providing sewer service described
36	in Attachment A to this ordinance is approved. Approval of this proposed annexation is
37	consistent with RCW 57.02.040.
38	SECTION 2. The Northeast Sammamish water and sewer district is the
39	appropriate entity to serve the area proposed to be annexed.

40 SECTION 3. Completion of this annexation does not constitute county approval

or disapproval of any other permits, certifications or actions necessary to provide service 41

42 to this annexation area.


