1	AN ORDINANCE approving the City of Duvall
2	Comprehensive Water System Plan.
3	
4	
5	PREAMBLE:
6	K.C.C. chapter 13.24 requires approval of comprehensive plans for water
7	utilities as a prerequisite for granting right-of-way franchises and approval
8	of right-of-way construction permits.
9	RCW 43.20.260 requires that water system plans for any new industrial,
10	commercial, or residential use are to be consistent with the requirements
11	of any comprehensive plans or development regulations adopted under
12	chapter 36.70A RCW or any other applicable comprehensive plan, land
13	use plan, or development regulation adopted by a city, town, or county for
14	the service area.
15	The city of Duvall currently provides water service to 5,200 residents and
16	several schools and businesses. The city is located in the northeast portion
17	of King County.

18	The city of Duvall obtains its water from Seattle Public Utilities. The
19	average annual water demand is currently 0.42 million gallons per day.
20	The demand is projected to increase to about 0.79 million gallons per day
21	in 2022, assuming a modest water conservation reduction of one-percent
22	per year.
23	The city of Duvall is planning a 10-year capital improvement program
24	valued at nearly \$6,300,000. The capital improvements proposed include
25	modifications to the storage and distribution systems.
26	The King County utilities technical review committee ("UTRC") reviewed
27	the plan for compliance with K.C.C. chapter 13.24, and conditionally
28	approved the plan on October 13, 2004. The conditions of approval have
29	been met in the plan copies attached to this ordinance. The UTRC
30	recommends that the King County council approve the plan.
31	A determination of nonsignificance for the plan was issued by the city of
32	Duvall on June 29, 2004, in accordance with the state Environmental
33	Policy Act.
34	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

35 SECTION 1.
