4	STATEMENT OF FACTS:	STATEMENT OF FACTS:	
5	1. The department of transp	portation declared the property located at 906	
6	Pine Street, Seattle, Washin	gton, located within council district four,	
7	surplus to its needs on Janua	ary 20, 2016.	
8	2. The facilities manageme	nt division offered the property to other county	
9	agencies on January 29, 201	6 and received no interest.	
10	3. The facilities manageme	nt division declared the property surplus to the	
11	current and future foreseeab	le needs of the county on March 1, 2016.	
12	4. The facilities manageme	nt division found the property suitable for	
13	affordable housing develop	nent on March 1, 2016.	
14	5. King County received co	ncurrence from the Federal Transit Agency on	
15	February 12, 2016, regardin	g the sale of the property.	
16	6. King County received an	offer from the Washington State Convention	
17	Center, a King County publ	ic facilities district utilizing its own funds and	
18	financing tools available to	it, and accepted a purchase price of one	
19	hundred sixty one million, t	en thousand, nine hundred forty dollars, based	

20	on a fair market value analysis.	
21	7. The Washington State Convention Center has offered either to provide	
22	affordable housing as a part of its proposed project or to contribute	
23	\$5,000,000.00 to an affordable housing program/fund managed by the	
24	department of community and human services, as specified in the	
25	purchase and sale agreement attached hereto.	
26	8. In accordance with K.C.C. 4.56.100.A.1. and K.C.C. 4.56.140.A., the	
27	county may dispose of real property to another governmental agency by	
28	negotiation, upon such terms as may be agreed upon and for such	
29	consideration as may be deemed by the county to be adequate.	
30	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:	
31	SECTION 1. The executive is authorized to convey the Convention Place Station	
32	to the Washington State Convention Center consistent with the terms set forth in the	
33	purchase and sale agreement substantially in the form of Attachment A to this ordinance	

34 and to take all actions necessary to implement the terms of the purchase and sale

35 agreement.
