SUBJECT: Amendments to the King County Auditor's Office 2017-18 Work Program

This memorandum invites you to review and seeks your input on proposed amendments to the Auditor's Office 2017-18 Work Program.

Each year the King County Auditor's Office submits an annual work program to the Government Accountability and Oversight (GAO) Committee for its approval. This work program outlines the audits and studies our office plans to conduct over the course of the biennium. Our 2017-18 work program was passed by the Metropolitan King County Council on February 13, 2017, as Motion 14802. A copy of this motion and adopted work program are attached.

In September, we brought two new capital projects oversight analysts into the Auditor's Office and conducted a strategic review of the program. Because of that analysis, we are proposing adding a set of capital program oversight activities to the list of specific capital projects we are overseeing. This will increase our ability to provide input in a timely way, when improvements are most impactful and least expensive to the county. In addition, the goal area programs and the Transit Active Service Management issues are not ready for full audits as described in the original work program. We are adding an open Transit audit item to ensure that we are using Transit audit resources to the highest impact. We included this set of projects through a review of County Council priorities, emerging issues, and evaluation of code-mandated audit work.

The table below highlights the proposed amendments.
