NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (the Council) held a public hearing in the Council Chambers on the 10th Floor of the King County Courthouse (516 Third Avenue, Seattle, WA) on Monday, December 4, 2017, beginning at 1:30 PM. The purpose of this public hearing was to consider adoption of Proposed Ordinance 2017-0317 (Ordinance 18623) adopting 2017 amendments to the 2016 King County Comprehensive Plan (KCCP) and the 2017 Vashon-Maury Island CSA Subarea Plan, Ordinance 18623 was adopted on December 4, 2017.

SUMMARY:

Proposed updates to the KCCP and the proposed Vashon-Maury Island CSA Subarea Plan were transmitted by the King County Executive on July 21, 2017. The updates were reviewed by the Transportation, Economy and Environment Committee, which adopted amendments and made its recommendation on October 17, 2017. Council action took place on December 4, 2017.
