1	AN ORDINANCE approving the Fall City Water District
2	2016 Water System Plan.
3	STATEMENT OF FACTS:
4	1. RCW 57.16.010 requires that general comprehensive plans by special
5	purpose districts be submitted to, and approved by, the legislative
6	authority within whose boundaries all or a portion of a utility lies. K.C.C.
7	chapter 13.24 prescribes the requirements for approval of those plans,
8	including consistency with state and local planning requirements.
9	K.C.C. chapter 13.24 also requires approval of comprehensive plans for
10	water and sewer utilities that provide service in unincorporated King
11	County as a prerequisite for operating in unincorporated King County,
12	receiving approval for annexation proposals, being granted right-of-way
13	franchises, and being given approval for right-of-way construction
14	permits.
15	2. The Fall City Water District's last general water plan was prepared in
16	2008. King County regulations require water system plans to be updated
17	every six years.
18	3. The district has a service area within King County and has adopted a
19	comprehensive water system plan ("the plan").

20	4. King County has adopted a Comprehensive Plan that includes policies
21	F-101 through F-254, the applicable portions of which address water
22	policies for facilities and services; these water policies call for consistency
23	with other adopted plans, pursuit of reclaimed water, water conservation
24	and protection of water resources.
25	5. K.C.C. chapter 13.24 requires the utilities technical review committee
26	to review and make a recommendation to the King County executive and
27	council on the plan, the requirements under K.C.C. chapter 13.24 and
28	consistency with the King County Comprehensive Plan. The utilities
29	technical review committee has reviewed the planning data and system
30	operations and has found:
31	a. The plan uses population and employment forecasts developed by the
32	Puget Sound Regional Council;
33	b. The district's service area includes portions of unincorporated King
34	County;
35	c. The capital facility plan is adequate to meet anticipated facility and
36	service needs;
37	d. The plan is consistent with applicable Washington state water quality
38	laws; and
39	e. The plan is consistent with other pertinent county adopted plans and
40	policies.
41	6. Washington state Department of Health approval is pending upon King
42	County's approval of the plan.

43	7. Under the state Environmental Policy Act the district completed an
44	environmental check list and the district issued a determination of
45	nonsignificance for the plan approval on May 1, 2017. There were no
46	appeals.
47	8. The district's operations and facilities meet multiple existing statutory,
48	administrative and planning standards. As the district's operations,
49	facilities and planning meet the requirements of the King County Code
50	and are consistent with the King County Comprehensive Plan, the utilities
51	technical review committee has recommended approval of the plan.
52	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
