1	AN ORDINANCE revising the corporate boundary of the
2	city of Covington to include the unincorporated portion of
3	Southeast 240th Street as provided for in RCW
4	35A.21.210.
5	STATEMENT OF FACTS:
6	1. It is in the county's best interest to allow cities within King County to
7	manage the entirety of roads that coincide with the city's boundaries.
8	RCW 35A.21.210 provides the mechanism to allow cities with King
9	County to adjust their boundaries to fully include roads on the cities'
10	boundaries within the city. RCW 35A.21.210 provides that "[t]he
11	governing bodies of a county and any code city located therein may by
12	agreement revise any part of the corporate boundary of the city which
13	coincides with the centerline, edge, or any portion of a public street, road
14	or highway right-of-way by substituting therefor a right-of-way line of the
15	same public street, road or highway so as fully to include or fully to
16	exclude that segment of the public street, road or highway from the
17	corporate limits of the city.
18	2. Revision of the corporate boundary of a city is effective upon approval
19	by the city council and the county legislative authority as provided for in

21	3. King County has jurisdiction over Southeast 240th Street from the
22	intersection of the west margin of 180th Avenue Southeast to the western
23	edge Covington Community Park (parcel number 2422059182) and
24	approximately 20 feet wide of the right-of-way from the west margin of
25	180th Avenue Southeast to the western edge of the Covington Aquatic
26	Center (parcel number 1822069168) and 20 feet wide of the right-of-way
27	from the eastern edge of the Covington Aquatic Center to the city
28	boundary.
29	4. It is in the city and the county's best interest to have the county right-
30	of-way portion of Southeast 240th Street under the city's jurisdiction so
31	that the city may provide local services to its residents including the
32	maintenance and operation of the public right-of-way.
33	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
34	SECTION 1. Findings:
35	A. A portion of the corporate boundary of the city of Covington currently extends
36	along the south margin of the right-of-way of Southeast 240th Street and another portion
37	of the corporate boundary extends within the right-of-way of SE 240th Street.
38	Approximately 0.42 miles of the Southeast 240th Street is located within unincorporated
39	King County of which approximately 0.17 miles is full width of the right-of-way and
40	approximately 0.25 miles is partial width of the right-of-way.
41	B. The Covington city council approved city of Covington Ordinance No. 23-
42	2017 to revise the city's corporate boundary at Southeast 240th Street to include the

- 43 portion of approximately 0.42 miles of public right-of-way currently within
- 44 unincorporated King County into the corporate limits of the city.
- 45 <u>SECTION 2.</u> The revision of the corporate boundary of the city of Covington to
- 46 include the portion of Southeast 240th Street public right-of-way currently within

- 47 unincorporated King County, legally described as set forth in Attachment A to this
- 48 ordinance, is hereby approved.

## ATTACHMENT 'A' SE 240<sup>TH</sup> ST. ANNEXATION DESCRIPTION

(KING COUNTY JURISDICTIONAL AREA BEING TRANSFERRED TO THE CITY OF COVINGTON) Those portions of SE 240th Street lying within the Southeast Quarter of Section 13 and the Northeast Quarter of Section 24, Township 22 North, Range 5 East, W.M., in King County, Washington, and lying easterly of the northerly projection of the westerly boundary of Parcel B of King County Exempt Segregation No. L02M0057, as recorded under Recording Number 20030129900001;

Together with those portions of SE 240th Street lying within the North 20 feet of the South 50 feet of Government Lot 4 (Southwest Quarter) of Section 18, Township 22 North, Range 6 East, W.M. as deeded to King County for right-of-way purposes by quit claim deed recorded under Recording Number 20091016000708;

Except that portion of said Government Lot 4 lying within the North 20 feet of the South 50 feet of the East 345.0 feet of the West 990.9 feet as measured at right angles to the south line of said Government Lot 4 as shown on said quit claim deed recorded under Recording Number 20091016000708.

The intent of this description is to annex that entire portion of SE 240th Street lying between King County and the City of Covington as described herein from the northerly projection of the westerly boundary of Parcel B of King County Exempt Segregation No. L02M0057 to the easterly line of Government Lot 4 of Section 18, Township 22 North, Range 6 East, W.M.
