11	in a total amount of \$300,000, and
12	WHEREAS, the city of Kent has agreed to prepare an analysis of the
13	design alternatives for the Project, in order to provide for the safety of residents and
14	businesses that are protected by the Levee, and
15	WHEREAS, the District and city of Kent ("the Parties") desire to
16	construct the Project as soon as possible, with a goal of construction in 2019, and
17	WHEREAS, the Parties desire to prepare an analysis and study of design
18	and construction alternatives for the Project, and select a preferred alternative for
19	recommendation to the District, and

WHEREAS, the Parties further intend that after the District selects a 20 design for the Project, the Parties will negotiate and enter into an agreement 21 22 regarding final design and construction of the Project; NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF 23 24 SUPERVISORS OF THE KING COUNTY FLOOD CONTROL ZONE DISTRICT: 25 <u>SECTION 1.</u> The board of supervisors approves the "Agreement Regarding Alternatives, Signature Pointe Levee Improvement Project, River Mile 21.7 to 23.2, 26 27 Right Bank," Attachment A to this resolution, and authorizes the chair to sign the agreement. 28
