NOTICE OF RULEMAKING – BOH 18-02

A Regulation Relating to Prohibiting
Use of Smokeless Tobacco at Event Sites
for Professional Sporting Events

Pursuant to its authority under RCW
70.05.060, the King County Board of Health
hereby gives notice of proposed rulemaking. The rule and regulation would add a new chapter to Title 19 of the Board of Health Code, named Regulation of Smokeless Tobacco at Event Sites for Professional Sporting Events. The chapter would prohibit smokeless tobacco use at any event sites for professional Sporting events and require each event site to have conspicuous signs clearly communicating that the use of smokeless tobacco is prohibited. The draft rule and regulation language gives the director of Public Health – Seattle & King County the authority to utilize Board of Health chapter 1.08 to enforce the signage requirement of the draft rule and regulation, and provides that event sites violating this section would be subject to a civil penalty of up to one hundred dollars per violation except at any event site with more than one thousand persons lawfully permitted to assemble at the venue, a civil penalty of one hundred dollars for every one thousand persons lawfully permitted to assemble at the venue, for each violation.

A public hearing on the proposed rule at which the public may state their views orally or in writing will be held during the regular meeting of the King County Board of Health, April 19, 2018 at 1:30 p.m. in the Metropolitan King County Council Chambers, 10th floor, Courthouse, 516 Third Avenue, Seattle, WA.
