Description of request:

This supplemental requests appropriation authority for all restoration and redundancy costs incurred due to the West Point Treatment Plant flood. These costs were not included in WTD's 2017-2018 operating and capital biennial budgets adopted by the Council in November, 2016, and include costs for labor, goods and services for operating and capital.

Does this legislation require a budget supplemental?

This legislation requires a supplemental of \$29.3M (\$16.1M operating/\$13.2M capital) to complete restoration and redundancy work due to the 2017 flood at the West Point Treatment Plant located in King County. The approval of this supplemental appropriation is essential as \$21.6M of the funds (\$10.9M op/\$10.7M capital) have already been expended under the emergency contracts related to the original flood event. This appropriation and completing the remaining restoration work reduces risk for WTD and the County.

The work identified in this supplemental will be concluded in 2018. Any remaining redundancy work will be appropriated in the 2019-20 biennial budget. Please see the financial plan included in the 2019-2020 WTD Sewer Rate submittal.

¹WTD anticipates that the majority of West Point restoration costs will be reimbursed by insurance.
