SUMMARY

The King County Flood Control Zone District (District) is a quasi-municipal corporation created pursuant to chapters 86.12 and 86.15 RCW, and is authorized by law to provide flood control improvements and flood protection services in order to protect life and property from flood water and to acquire property interests by condemnation. By Resolution No. FCD2017-072, adopted on November 13, 2017, the District board of supervisors approved the Lower Russell Road Leve Setback flood protection capital project and funding for the project (Project), which as been given identifying number 1132056.

An interlocal aursement between King County.

has been given identifying number 1112056.

An interlocal agreement between King County and the District authorizes King County to condemn all real property interests that are necessary to carry out a district flood protection capital project. In order to allow the construction of the Project, King County purchased several properties in the Project area, including a warehouse located at 22230 Russell Road S. in the City of Kent (Property). The Project requires the warehouse on the Property to be demolished and removed. One tenant at the Property Amana Global Company (Amana) remains at the Property by virtue of a sixty-month lease that was executed prior to King County's purchase of the Property (the "Leasehold Interest"). King County has been unable to agree with Amana regarding King County's purchase of the Leasehold Interest.

In accordance with the requirements of the in-

In accordance with the requirements of the in-terlocal agreement, the District intends to au-thorize King County to condemn the Leasehold Interest through the Proposed Resolution. If Dis-trict authorization is provided, the King County Council Intends to take final action by considering Proposed Ordinance 2018-0258.
