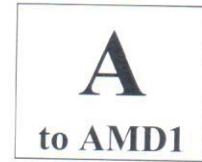

1 **AMENDMENT TO PROPOSED ORDINANCE 2018-0373, VERSION 2**

2 On page 6, beginning on line 117 strike everything through line 121 and insert

3 "NEW SECTION. SECTION 3. It is unlawful for any person in King County,
4 state of Washington, outside the boundaries of incorporated cities and towns within King
5 County, to store or keep a firearm, ^{LOADED FIREARM} whether loaded or unloaded with ammunition, within
6 any premises unless the firearm is safely stored in or using a secure firearm storage or
7 safety device. Notwithstanding the foregoing, for purposes of this section, such firearm
8 shall be deemed lawfully stored or lawfully kept if carried by or under the control of the
9 owner, lawfully authorized user or law enforcement officer on duty and following the law
10 enforcement officer's agency's policies."

12 ***EFFECT: The amendment would allow firearm to be deemed lawfully stored or***
13 ***lawfully kept if carried by or under the control of the owner, lawfully authorized user***
14 ***or law enforcement officer on duty and following the law enforcement officer's***
15 ***agency's policies.***

2 On page 7, after line 137 insert

3 "NEW SECTION. SECTION 5. The prosecuting attorney's office shall produce
4 a quarterly report showing the costs incurred by the prosecuting attorney's office as a
5 result of this chapter, which shall include, but not limited to, any litigation against the
6 county. The report shall be transmitted in the form of a paper original and an electronic
7 copy with the clerk of the council, who shall retain the original and provide an electronic
8 copy to all councilmembers, the council chief of staff and the lead staff to the law and
9 justice committee or its successor."

10 Renumber any remaining subsections consecutively and correct any internal references
11 accordingly.

13 ***EFFECT: The amendment would require the Prosecuting Attorney's Office (PAO) to***
14 ***provide a quarterly report to the council on the costs incurred by the PAO due to the***
15 ***proposed ordinance including any litigation costs.***
