1 **AMENDMENT TO PROPOSED ORDINANCE 2018-0375, VERSION 3**

2 Beginning on page 6, strike lines 129 through 132 and insert:

3 "NEW SECTION. SECTION 6. There is hereby added to K.C.C. chapter 10.08 a
4 new section to read as follows:

5 The solid waste division shall transmit to the council annually by April 1 the
6 report required by WAC 173-351-200 (11), as amended. The report shall be filed in the
7 form of a paper original and an electronic copy with the clerk of the council, who shall
8 retain the original and provide an electronic copy to all councilmembers, the council chief
9 of staff and the lead staff to the committee of the whole or its successor.

10 SECTION 7. Sections 1 through 6 of this ordinance take effect forty-five days
11 after the solid waste division transmits the 2019 Comprehensive Solid Waste
12 Management Plan to the Washington state Department of Ecology, unless the
13 Washington state Department of Ecology disapproves the plan."

15 In Attachment A, on page Att A Page 164, after "It will also provide a basis for
16 determining if bird use of the area changes through time" insert a new paragraph:
17 "In recognition of the longer life of the landfill and to ensure transparency of landfill
18 operations, the solid waste division shall transmit to the council each year the annual

19 report submitted to the local health jurisdiction and the department of ecology, as
20 required by WAC 173-351-200 (11), as amended."

22 **EFFECT: *Requires the solid waste division to transmit to Council the annual report***
23 ***required by WAC 173-351-200 (11), which includes data on groundwater monitoring***
24 ***and leachate analysis for the Cedar Hills Regional Landfill.***
