1 A RULE AND REGULATION relating to the time of the  
2 regular meetings of the Board of Health; and amending  
3 R&R 09-04, Section 4, as amended, and BOH 2.04.055.

4 BE IT ADOPTED BY THE KING COUNTY BOARD OF HEALTH:

5 SECTION 1. R&R 09-04, Section 4, as amended, and BOH 2.04.055 are each  
6 amended to read as follows:

7 **Rule 4. Meetings.**

8 A. The time of the regular meeting of the board shall be at ((1:30)) 1:00 p.m. on  
9 the third Thursday of each month or, if the third Thursday falls on or near a legal holiday,  
10 an alternative date may be determined by the chair.

11 B. Any regular meeting of the board may be cancelled by the chair of the board.

12 C. All regular meetings of the board shall be held in the King County council  
13 chambers on the tenth floor of the King County Courthouse in Seattle, Washington.

14 D. The chair or boardmembers representing seven votes may call a special  
15 meeting of the board consistent with the provisions of RCW 42.30.080.

16 E. The board may hold executive sessions from which the public may be  
17 excluded for purposes set forth in, and in compliance with, RCW 42.30.110.

18 F. Whenever, due to an emergency, as defined in K.C.C. 12.52.010, it is  
19 imprudent, inexpedient or impossible to conduct the affairs of the board at the regular or

20 usual place, the board may meet at any place within or without the territorial limits of the  
21 county on the call of the chair or any two members of the board. After an emergency  
22 relocation, the affairs of the board shall be lawfully conducted at the emergency location  
23 for the duration of the emergency. The notices required in Rule 6.B. shall be suspended  
24 during the period of the emergency.

25 G. All regular and special meetings of the board shall be open to the public, and  
26 conducted in accordance with chapter 42.30 RCW. The board may order the removal of  
27 individuals who are interrupting the meeting and may adjourn and reconvene in another  
28 location as provided in RCW 42.30.050.

29 H. The proceedings of all board meetings shall be recorded electronically, unless  
30 the meeting is an emergency meeting as provided in Rule 4.F.


