1 A MOTION confirming the appointment of Eliseo Juarez
2 to the citizens' elections oversight committee as the
3 representative of the Spanish-speaking community.

4 WHEREAS, in 2018, through Ordinance 18795, King County council added a
5 position on the citizens' election oversight committee to represent the Spanish-speaking
6 community, and

7 WHEREAS, King County is committed to conducting open, accurate and fair
8 elections, and

9 WHEREAS, the citizens' election oversight committee help to ensure that
10 accountability and performance of the elections division is provided in a transparent
11 manner that is meaningful to King County residents, and

12 WHEREAS, fifteen of the sixteen positions on the citizens' election oversight
13 committee are currently vacant, and

14 WHEREAS, in accordance with K.C.C. 2.53.021, King County council is tasked
15 with appointing new members of the citizens' election oversight committee, and

16 WHEREAS, in accordance with K.C.C. 2.28.010, when the King County council
17 recreates a board with more than nine members, the appointed terms are staggered: one-
18 fourth for one year, one-fourth for two years, one-fourth for three years or the full term if
19 the full term is three years, and one-fourth for full terms, and

20 WHEREAS, in accordance with K.C.C. 2.53.021, the employment and
21 administration committee of the King County council appointed Eliseo Juarez on July 15,
22 2019;

23 NOW, THEREFORE, BE IT MOVED by the Council of King County:

24 The appointment of Eliseo Juarez to serve on the citizens' elections oversight

25 committee as a representative of the Spanish-speaking community for a three-year

26 staggered term ending July 2022 is hereby confirmed.
