| 15 | STATEMENT OF FACTS: |
| 16 | 1. Adoption of Ordinance 18774 in 2018 set in motion King County's |
| 17 | Land Conservation Initiative with the goal of conserving and preserving |
| 18 | the last remaining high conservation value lands throughout King County |
| 19 | within thirty years, both in unincorporated areas and within cities, to |

| 20 | maintain and sustain the quality of life, livability and strength of our |

| 21 | region's economy. |
| 22 | 2. For decades, King County has demonstrated leadership in protecting |
| 23 | open space. In 1982, King County initiated its conservation futures tax |
| 24 | ("CFT") levy program, which has successfully protected more than one |
| 25 | hundred thousand acres of valuable forestlands, farmlands, open spaces, |
| 26 | natural lands and urban greenspaces. |
| 27 | 3. This long legacy of open space conservation has made King County |
| 28 | one of the most livable areas in the country and a sought-after place to |
| 29 | live, work and do business. However, many communities across King |
| 30 | County lack basic levels of open space infrastructure, and ready access to |
| 31 | parks, greenspaces and trails. |
| 32 | 4. An advisory group of regional leaders helped shape the Land |
| 33 | Conservation Initiative, providing a final report in December 2017. The |
| 34 | report stated that, "While we live in a region with a strong history of |
| 35 | protecting open spaces, not all of our communities have experienced the |
| 36 | benefits of past investments. There are many neighborhoods in which the |
| 37 | past history of inequities, discrimination, injustices, and limited regional |
| 38 | investment is evident today and affects the daily life of the residents." |
| 39 | Therefore, a central goal of the Land Conservation Initiative is to |
| 40 | eliminate disparities in access to open space resources. |
| 41 | 5. The advisory group recommended the county establish an open space |
| 42 | equity cabinet to help set policy, and oversee and monitor progress |

| 43 | towards the addition of greenspaces in priority equity areas with the |
|----|---|
| 44 | greatest and most acute needs. |
| 45 | 6. In April 2018, the county executive convened an open space equity |
| 46 | cabinet comprised of community leaders. Their work culminated in a |
| 47 | report submitted to the executive and council in March 2019 that |
| 48 | recommends strategies and actions to embed an equity-based approach for |
| 49 | investments in open space infrastructure to redress the disparities in access |
| 50 | to parks and open space. |
| 51 | 7. The open space equity cabinet recommended specific revisions to |
| 52 | K.C.C. chapter 26.12, related to the CFT grant program. Their revisions, |
| 53 | which are in this ordinance, were developed in concert with the CFT |
| 54 | advisory committee and the department of natural resources and parks. |
| 55 | The revisions build on the long-standing success of CFT and seek to |
| 56 | ensure all residents of King County have access to open space. |
| 57 | 8. Revisions to K.C.C. chapter 26.12 included in this ordinance further |
| 58 | the goals and strategies of the King County Equity and Social Justice |
| 59 | Ordinance, Ordinance 16948, and the county's 2016 adopted Equity and |
| 60 | Social Justice Strategic Plan. |
| 61 | 9. The revisions to K.C.C. chapter 26.12 also clarify policies and |
| 62 | practices, eliminate outdated sections of the code and support more |
| 63 | efficient management and implementation of the CFT grant program. |
| 64 | Additionally, code revisions to K.C.C. chapters 2.28 and 2.36 modify the |
| 65 | name and term structure of the conservation futures advisory committee. |

| 66 | BE IT ORDAINED BY THE COUNCIL OF KING COUNTY: |

| 67 | SECTION 1. Ordinance 13717, Section 1, as amended, and K.C.C. 26.12.003 are |
| 68 | hereby amended to read as follows: |
| 69 | The definitions in this section apply throughout K.C.C. 26.12.003 through |
| 70 | ((26.12.035)) 26.12.100 unless the context clearly requires otherwise. |
| 71 | A. "Advisory committee" means the conservation futures advisory committee, |
| 72 | established under K.C.C. 2.36.070. |
| 73 | B. "Agency" means King County or any city, town or metropolitan park district |
| 74 | within King County. |
| 75 | \underline{C} . "Annual allocation" means the allocation of conservation futures tax levy |
| 76 | ((funds)) proceeds collected in the ensuing budget year and other moneys deposited in the |
| 77 | conservation futures fund. |
| 78 | ((B. "Citizen oversight committee" means the citizen oversight committee, |
| 79 | established under K.C.C. 2.36.070. |
| 80 | C. "Conservation futures tax levy funds" means moneys collected through the tax |
| 81 | levy upon all taxable property in King County authorized by RCW 84.34.230.)) |
| 82 | D. "Conservation futures fund" means the King County conservation futures fund |
| 83 | established under K.C.C. 4A.200.210. |
| 84 | E. (("Equity areas" means areas within King County that meet all three of the |
| 85 | specified criteria listed below, or areas where the project proponents or proponents can |
| 86 | demonstrate, and the citizen oversight committee determines, that residents living in the |
| 87 | area experience disproportionately limited access to public open spaces as well as |
| 88 | demonstrated hardships such as, but not limited to, chronic low incomes, persistent poor |

| 89 | health, or high rates of utilization of free and reduced price school meals. The three |

| 90 | specific criteria are: areas located in a census tract in which the median household |
| 91 | income is in the lowest one-third for median household income for census tracts in King |
| 92 | County; areas located in a census tract in which hospitalization rates for asthma, diabetes, |
| 93 | and heart disease are in the highest one-third for census tracts in King County; and for |
| 94 | areas within the Urban Growth Boundary, do not have a publicly owned and accessible |
| 95 | park within one-quarter mile of a residence, or for areas outside the Urban Growth |
| 96 | Boundary that do not have a publicly owned and accessible park within two miles of a |
| 97 | residence. The department of natural resources and parks shall identify and update equity |
| 98 | areas at least every five years.)) "Conservation futures tax levy proceeds" means moneys |
| 99 | collected through the tax levy upon all taxable property in King County authorized by |
| 100 | <u>RCW 84.34.230.</u> |
| 101 | F. (("Governmental agency" and "agency" mean King County or any city within |
| 102 | King County.)) "Equity" means all people have full and equal access to opportunities |
| 103 | that enable them to attain their full potential. |
| 104 | G. "Nongovernmental organization" means any group of two or more persons |
| 105 | that is not an agency as defined by this chapter. |
| 106 | H. "Nonprofit organization" means nonprofit historic preservation corporation as |
| 107 | defined in RCW 64.04.130 or nonprofit nature conservancy corporation or association as |
| 108 | defined in RCW 84.34.250. |
| 109 | \underline{I} . "Open space land" means the fee simple interest in open space land, farm and |
| 110 | agricultural land and timber land as those terms are defined in chapter 84.34 RCW, |
| 111 | including urban greenspaces in dense urban environments, for public use or enjoyment, |

| 112 | or any lesser interest in those lands, including development rights, conservation futures, |

| 119 | b. are located in a ZIP code in which hospitalization rates for asthma, diabetes |
| 120 | and heart disease are in the highest one-third for ZIP codes in King County; and |
| 121 | c. are within the Urban Growth Boundary and do not have a publicly owned |
| 122 | and accessible park or open space within one-quarter mile of a residence, or are outside |
| 123 | the Urban Growth Boundary and do not have a publicly owned and accessible park or |
| 124 | open space within two miles of a residence; or |
| 125 | 2. Areas where the project proponent or proponents can demonstrate, and the |
| 126 | advisory committee determines, that residents living in the area, or the populations the |
| 127 | project is intended to serve, disproportionately experience limited access to public open |
| 128 | spaces and experience demonstrated hardships including, but not limited to, low income, |
| 129 | poor health and social and environmental factors that reflect a lack of one or more |
| 130 | conditions for a fair and just society as defined as "determinants of equity" in K.C.C. |
| 131 | 2.10.210. |
| 132 | K. "Project" means open space land to which ((King County)) conservation |
| 133 | futures tax levy ((funds)) proceeds are allocated for acquisition under the processes under |
| 134 | K.C.C. 26.12.010. |

| 135 | L. "Reviewed appraisal" means a property appraisal performed within two years |

| 136 | of the application deadline set in K.C.C. 26.12.010.A. by an independent state-certified |
| 137 | real estate appraiser with a current general real estate appraiser license and reviewed by |
| 138 | an independent state-certified general real estate appraiser. |
| 139 | M. "Social justice" means all aspects of justice, including legal, political, and |
| 140 | economic, and requires the fair distribution of public goods, institutional resources and |
| 141 | life opportunities for all people. |
| 142 | SECTION 2. Ordinance 8867, Section 2, as amended, and K.C.C. 26.12.005 are |
| 143 | hereby amended to read as follows: |
| 144 | This section describes goals of the county conservation futures tax allocations |
| 145 | over time. In accordance with chapter 84.34 RCW, ((it shall be the goal of the county |
| 146 | to)) the county shall maintain, preserve, conserve, expand and otherwise continue in |
| 147 | existence adequate open space lands, and $((to))$ the county shall also achieve $((an$ |
| 148 | equitable)) a broad geographical distribution of ((funds from conservation futures over |
| 149 | the long term. The citizens oversight committee shall also include in its recommendation |
| 150 | to the executive a description of how projects contain a demonstrable regional visibility, |
| 151 | use, ecological, cultural, historical or other natural resource significance)) conservation |
| 152 | futures proceeds. Conservation futures proceeds shall be allocated in a manner that |
| 153 | addresses equity and social justice by providing open spaces in communities in greatest |
| 154 | need. |
| 155 | SECTION 3. Ordinance 8867, Section 1, as amended, and K.C.C. 26.12.010 are |
| 156 | hereby amended to read as follows: |
| 157 | A process is hereby established for the annual allocation of the conservation |

| 158 | futures tax levy ((funds,)) proceeds to acquire open space lands, including greenspaces, |
|-----|---|
| 159 | greenbelts, wildlife habitat and trail rights-of-way proposed for preservation for public |
| 160 | use by either((the county or the cities)) agencies or nonprofit organizations within the |
| 161 | county. ((King County, cities within the county, citizen groups and citizens)) Agencies, |
| 162 | nonprofit organizations, nongovernmental organizations and individuals may make |
| 163 | application for ((funds)) proceeds in this allocation process. In accordance with chapter |
| 164 | 84.34 RCW, only agencies and nonprofit organizations are eligible to receive |
| 165 | conservation futures funding to acquire property. |
| 166 | A. The ((county executive)) department of natural resources and parks shall |
| 167 | determine a date, no later than April 1, as a deadline for submission of applications for |
| 168 | use of conservation futures tax levy ((funds)) proceeds. At least one month before the |
| 169 | application submission deadline date, the ((executive)) department shall provide ((all |
| 170 | eities within the county)) notice on the King County website of the opportunity to apply |
| 171 | to the county for a share of the annual allocation of the conservation futures tax levy |
| 172 | ((funds)) proceeds available for that year. ((Notice also shall be provided on the King |
| 173 | County website.)) The department shall also provide notice by email to all agencies, |
| 174 | nonprofit organizations, nongovernmental organizations and individuals anticipated to |
| 175 | have potential interest in conservation futures funding. The department shall maintain |
| 176 | and update a list of parties anticipated to be interested in conservation futures funding. |
| 177 | B. No later than March 1, the county council may adopt a motion that provides |
| 178 | direction to the ((eitizen oversight)) advisory committee on priorities for evaluating the |
| 179 | applications within the open space criteria identified in K.C.C. $((27.02.025))$ <u>26.12.025</u> . |
| 180 | C.1. By July 15, the ((eitizen oversight)) advisory committee shall make project |

| 181 | recommendations and recommend funding allocations for each project to the executive, |

| 182 | including: |
| 183 | a. a description of each project including project location and acreage; |
| 184 | b. a report on how each project meets the county open space selection criteria, |
| 185 | contained in K.C.C. 26.12.025; ((and)) |
| 186 | c. the amount of funding requested in each project application; ((and)) |
| 187 | d. any additional relevant criteria of the jurisdiction in which the potential |
| 188 | acquisition is located; and |
| 189 | e. a description of how projects contain a demonstrable regional visibility, use, |
| 190 | ecological, cultural, historical or other natural resource significance. |
| 191 | 2. The executive shall transmit the advisory committee's project and funding |
| 192 | recommendations for the following year to the council no later than July 31. The report |
| 193 | shall be filed in the form of a paper original and an electronic copy with the clerk of the |
| 194 | council, who will retain the original and provide an electronic copy to all |
| 195 | councilmembers, the council chief of staff and the lead staff to the mobility and |
| 196 | environment committee or its successor. |
| 197 | $\underline{3}$. The committee's recommendations are solely advisory and the executive |
| 198 | and/or the council may adopt, alter, add to or decline to adopt all or part of the |
| 199 | committee's recommendations in the budget process. |
| 200 | D. The executive's project and funding recommendation shall be ((included in the |
| 201 | annual proposed)) transmitted with the applicable appropriation ordinance ((for the |
| 202 | ensuing budget year)). |
| 203 | E.((1. Except as otherwise provided in subsection E. 2. and 3. of this section, any |

| 204 | application funded by this process shall be sponsored and forwarded by the jurisdiction in |

| 205 | which the project is located.)) Except for acquisitions of property interests in ((equity)) |
| 206 | opportunity areas, the ((jurisdiction)) agency or nonprofit organization receiving |
| 207 | conservation futures tax levy proceeds shall commit to providing a matching contribution |
| 208 | no less than the amount of conservation futures tax levy ((funds)) proceeds appropriated |
| 209 | for the project before conservation futures tax levy ((funds)) proceeds are reimbursed to |
| 210 | that ((jurisdiction)) agency or nonprofit organization. ((This)) The contribution may |
| 211 | consist of cash, land ((trades)) match with a valuation verified by an a reviewed appraisal |
| 212 | ((by a Member of the Appraisal Institute (MAI) certified appraiser)) or the cash value, |
| 213 | excluding King County conservation futures contributions, of other open spaces acquired |
| 214 | within the previous two years ((that is either directly adjacent to the project or the county |
| 215 | concludes to be directly linked to the property under application)) from the date of the |
| 216 | submittal of the application by the agency or nonprofit organization. Properties |
| 217 | considered as land match or cash value of other open space acquisitions should be |
| 218 | directly linked to the property under application. |
| 219 | F.1. If an application by an agency other than King County is funded by this |
| 220 | process, the agency shall enter into an interlocal agreement with the county. |
| 221 | 2. ((A jurisdiction may make an application in partnership with one or more |
| 222 | jurisdictions if the proposed project lies wholly within the boundaries of those |
| 223 | jurisdictions, or if another reason for such a partnership is articulated within the |
| 224 | application, such as a trail connection, a community separator or coordinated salmon |
| 225 | habitat preservation. In such a partnership application, the relationship, roles and |
| 226 | responsibilities for acquisition, ownership, any matching contribution obligations and |
| | |

future maintenance must be described. If a partnership application is funded by this
 process, the jurisdictions shall be required to enter into an interlocal agreement with the
 county formalizing the relationship, roles and responsibilities for acquisition, ownership,
 any matching contribution obligations and future maintenance.

3. For an application by a citizen or citizen group, except for acquisitions of 231 property interests in equity areas, the citizen or citizen group shall commit to providing a 232 matching contribution no less than the amount of conservation futures tax levy funds 233 appropriated for the project. This contribution may consist of cash, land trades with a 234 valuation verified by an appraisal by a Member of the Appraisal Institute (MAI) certified 235 appraiser or the cash value, excluding King County conservation futures contributions, of 236 other open spaces acquired within the previous two years that is either directly adjacent to 237 the project or the county concludes to be directly linked to the property under application. 238 For a project based on an application by a citizen or citizen group, the funds shall be 239 reimbursed to the jurisdiction in which the project is located. If a citizen or citizen 240 group's application is funded by this process, the jurisdiction in which the project is 241 located shall be required to enter into an interlocal agreement with the county formalizing 242 the relationship, roles and responsibilities for acquisition, ownership, any matching 243 contribution obligations and future maintenance.)) If an application by a nonprofit 244 organization is funded by this process, the organization shall enter into an agreement with 245 the county. Before a funding award is paid to a nonprofit organization, the organization 246 shall obtain a letter of intent from an agency or a separate nonprofit organization that 247 indicates that if in the future the acquiring organization ceases to exist, the agency or the 248 separate organization is willing to be identified on title to the acquired property as an 249

| 250 | owner. If the property is in the unincorporated area and the nonprofit organization seeks |

| 252 | department of natural resources and parks, or a metropolitan park district within the |
| 253 | boundaries of which the property is located. If the property is in an incorporated area and |
| 254 | the nonprofit organization seeks an agency letter, the organization shall request the letter |
| 255 | from the agency of the jurisdiction in which the project is located, or a metropolitan park |
| 256 | district within the boundaries of which the property is located. If the property is in an |
| 257 | incorporated area, in the event that the legislative body of the agency of the incorporated |
| 258 | area or the park district indicates in writing or through a formal vote that it is not willing |
| 259 | to provide the letter, the nonprofit organization may request a letter from King County. |
| 260 | For any acquisition by a nonprofit organization, King County shall ensure a restriction is |
| 261 | recorded on the chain of title to preserve the conservation values of the property in |
| 262 | perpetuity. |
| 263 | 3. If an application by a nongovernmental organization or individual is funded |
| 264 | by this process, the award shall be made either to a nonprofit organization or an agency. |
| 265 | K.C.C. 26.12.010.F.1. applies to an award to an agency. K.C.C. 26.12.010.F.2. applies to |
| 266 | an award to a nonprofit organization. |
| 267 | ((F.)) G. If the King County transfer of development rights program bank, as |
| 268 | established by K.C.C. chapter 21A.37, is awarded conservation futures levy ((funds)) |
| 269 | proceeds in order to purchase development rights and thereby preserve open space in |
| 270 | accordance with purposes and provisions of this chapter, the bank is authorized to sell |
| 271 | those development rights and to use the proceeds from that sale to acquire additional |
| 272 | development rights, thereby preserving additional open space lands in accordance with |
| | |

| 273 | the terms and provisions of this chapter. When transferrable development rights are |

| 274 | purchased by the bank in accordance with K.C.C. chapter 21A.37 using conservation |

| 282 | $((G_{\cdot}))$ <u>H.</u> Conservation futures tax levy $((funds))$ proceeds shall be deposited in |
| 283 | the conservation futures fund for the purpose of administering, disbursing and accounting |
| 284 | for conservation futures tax levy ((funds)) proceeds authorized by King County. |
| 285 | Conservation futures tax levy ((funds)) proceeds shall be disbursed to projects previously |
| 286 | approved by King County upon receipt and verification by King County of properly |
| 287 | completed requests for payment of the ((funds)) proceeds. The office of performance, |
| 288 | strategy and budget shall prescribe the form for the requests. The disbursement requests |
| 289 | shall be made only for capital project expenditures that include all costs of acquiring real |
| 290 | property, including interests in real property, and the following costs, though it shall not |
| 291 | include the cost of preparing applications for conservation'futures moneys: cost of |
| 292 | related relocation of eligible occupants; cost of appraisal; cost of appraisal review; cost of |

| 294 | hazardous waste substances reports; directly related staff costs; and related legal and |
| 295 | administrative costs. ((The city shall transmit payment to its payees for current capital |

| 298 | requests to King County.)) The agency or nonprofit organization shall have the property |
| 299 | valued by a reviewed appraisal. The ((eity)) agency or nonprofit organization is |
| 300 | responsible for the accuracy of the payment requests and the propriety and timeliness of |
| 301 | its disbursements following receipt of conservation futures tax levy ((funds)) proceeds. |
| 302 | Conservation futures tax levy ((funds)) proceeds may not be used to acquire any property |
| 303 | or interest therein through the exercise of the power of eminent domain. |
| 304 | ((H.)) I. Projects carried out ((by a governmental agency)) in whole or part with |
| 305 | conservation futures tax levy ((funds)) proceeds shall not be transferred or conveyed |
| 306 | except to an agency or nonprofit organization by ((interlocal)) written agreement |
| 307 | providing that the land or interest in land shall be continued to be used for the purposes of |
| 308 | K.C.C. ((26.12.005 through 26.12.025)) chapter 26.12 and in strict conformance with the |
| 309 | uses authorized under ((RCW 84.34.230)) chapter 84.34 RCW. ((Also, t))The land or |
| 310 | interest in land shall not be converted to a different use unless other equivalent lands |
| 311 | within ((the geographic jurisdiction of the governmental agency)) King County are |
| 312 | received in exchange for the lands or interest in lands, or cash reimbursement is made. |
| 313 | The land shall be valued in its changed status or use, and not based upon its value as open |
| 314 | space, and the replacement land or payment amount must be acceptable to King County. |
| 315 | Before the conversion of conservation futures land to another use, the department of |
| 316 | natural resources and parks shall provide written notification to the council. If the |
| 317 | proposal is to convert one-half acre or more of conservation futures land, or if the |
| 318 | conservation futures land to be converted is valued at more than fifty thousand dollars, |

| 319 | and the proposal is either for a cash reimbursement or for proposed equivalent lands that |
| 320 | are not within the same jurisdiction as the conservation futures land proposed to be |

| 322 | the proposal, submit the written notification to the council. Unless the council passes a |
| 323 | motion rejecting the proposal within sixty days of receiving the notification, the |
| 324 | executive may proceed with the proposal. The sixty-day waiting period shall not apply |

345 <u>SECTION 4.</u> Ordinance 13717, Section 4, as amended, and K.C.C. 26.12.025 are
346 hereby amended to read as follows:

In making an annual allocation of conservation futures tax levy ((funds))
 proceeds, the county shall consider the following criteria, not listed in priority order:

wildlife habitat or rare plant reserve; salmon habitat and aquatic resources; scenic

350 resources; community separator; historic or cultural resources; urban passive-use natural

area or greenbelt; park, ((or)) open space <u>or natural corridor</u> ((system)) addition; and

352 ((transfer of development rights program implementation)) passive recreation opportunity

in an area with unmet needs; and projects that seek to redress historic disparities in access

354 to or health benefits of open space in opportunity areas. Additional criteria may include:

355 ((passive recreation;)) education<u>al</u> ((f)) <u>or</u> interpretive opportunity; ((threat of loss of))

impact to open space resources; feasibility, including ownership complexity, a willing

357 seller or sellers or community support; partnerships; if the property identified in an

358 adopted comprehensive plan, park open space, habitat, cultural resource or community

359 plan; transfer of development rights participation; stewardship and maintenance;

360 ((equity)) regional significance; adopted financial policies; and any other criteria

361 consistent with ((RCW 84.34.020) chapter 84.34 RCW.

362 SECTION 5. Ordinance 14714, Section 6, as amended, and K.C.C. 26.12.035 are

363 hereby amended to read as follows:

364 A. Each ((governmental)) agency or nonprofit organization receiving conservation

If sufficient ((funds)) proceeds are not 417 available to complete the acquisition of all available property interests in a particular year, 418 priority should be given to protecting parcels in ((equity)) opportunity areas and parcels 419 most at risk for development. 420 G. ((Funds)) Proceeds should remain available ((on an annual basis)) annually to 421 pursue ongoing and emerging opportunities to acquire conservation lands. 422 SECTION 7. Each councilmember must provide the executive with a nomination to represent 425 the councilmember's council district.
