1	AGREEMENT BETWEEN
2	INTERNATIONAL FEDERATION OF PROFESSIONAL AND TECHNICAL ENGINEERS,

6	
7	These Articles constitute an agreement between King County ("County") and the International
8	Federation of Professional and Technical Engineers, Local 17 ("Union"). This Agreement shall be
9	subject to approval by Ordinance by the Metropolitan King County Council ("Council").
10	ARTICLE 1: PURPOSE AND DEFINITION
11	1.1 Purpose - The intent and purpose of this Agreement is to promote the continued
12	improvement of the relationship between the County and its employees and to set forth the wages,
13	hours and working conditions of such employees.
14	1.2 Definitions - All words under this Agreement shall have their ordinary and usual meaning
15	except those words that have been defined under KCC 3.12, as amended, or which are specifically
16	defined in this Agreement.
17	1.3 Labor-Management Committee: The parties shall convene a bargaining unit wide
18	Labor-Management Committee meeting whenever they jointly agree that such a meeting is desirable.

#### ARTICLE 2: UNION RECOGNITION AND MEMBERSHIP

2.1 Recognition - The County recognizes the Union as the exclusive bargaining 2 representative of all employees whose job classifications are listed in the attached Addendum "A". 3

2.2 Membership - It shall be a condition of employment that all employees covered by this 4 5 Agreement who are members of the Union in good standing on the effective date of this Agreement shall remain members in good standing or pay an agency fee to the Union in lieu of membership, and 6 7 those who are not members of the Union on the effective date of this Agreement, shall become and remain members in good standing or pay an agency fee to the Union in lieu of membership. It shall 8 also be a condition of employment that all employees covered by this Agreement and hired or 9 assigned into the bargaining unit on or after its effective date shall, by the thirtieth (30th) day 10 following the beginning of such employment, become and remain members in good standing or pay 11 12 an agency fee to the Union in lieu of membership.

2.2.1 An employee who can substantiate, in accordance with existing law, bona fide religious 13 tenets or beliefs that prohibit the payment of dues or initiation fees to union organizations shall pay an 14 amount of money equivalent to regular union dues and initiation fee to a non-religious charitable 15 organization mutually agreed upon by the employee affected and the Union to which such employee 16 would otherwise pay the dues and initiation fee. If the employee and the Union do not reach 17 agreement on such matter, the Public Employment Relations Commission (PERC) shall designate the 18 charitable organization. The employee shall furnish written proof that such payment has been made. 19

20 2.2.2 Failure by an employee to abide by the above provisions shall constitute cause for discharge of such employee; provided, that when an employee fails to fulfill the above obligation, the 21 Union shall provide the employee and the County with thirty (30) days written notification of the 22 Union's intent to initiate discharge action, and during this period the employee may make restitution 23 in the amount which is overdue. 24

2.3 Dues Deduction - Upon receipt of written authorization individually signed by a bargaining unit employee, the County shall have deducted from the pay of such employee the amount 26 of dues as certified by the secretary of the Union and shall transmit the same to its treasurer. 27

2.4 Indemnification - The Union will indemnify and hold the County harmless against any

1	claims made and against any suit instituted against the County on account of any check-off of dues for
2	the Union. The Union agrees to refund to the County any amounts paid to it in error on account of
3	the check-off provision upon presentation of proper evidence thereof.
4	2.5 Employee List - The County will transmit to the Union, upon request, a current listing of
5	all employees in the bargaining unit. Such list shall indicate the name of the employee, position, job
6	classification, department and/or unit.

#### ARTICLE 3: RIGHTS OF MANAGEMENT AND WAIVER CLAUSE

3.1 Rights of Management - The management of the County and the direction of the work 2 force is vested exclusively in the County, except as may be limited by the express written terms of 3 this Agreement. All matters, including but not limited to, the right to hire, appoint, promote, 4 discipline and discharge regular employees for cause, improve efficiency, train, assign and direct the 5 work force, develop and modify classification specifications, allocate positions to those 6 classifications, determine work schedules, determine location of facilities, contracting out of work, 7 and determine methods, processes and means for providing services, may be administered for its 8 duration by the County in accordance with such policy or procedures as from time to time may be 9 determined. The County agrees not to contract out work historically performed by members of the 10 bargaining unit if the contracting of such work eliminates or reduces the normal workload of the 11 bargaining unit. If in order to secure funding for a specific project the County is required to contract 12 all or part of the work to be performed due to limitations imposed by the funding agreement, said 13 contracting shall not be considered a violation of this Article as long as it does not eliminate or reduce 14 the normal workload of the bargaining unit. The County agrees to provide the Union, upon request, 15 with documentation to support any contracting of work under the terms of this section. 16

3.2 Waiver Clause - The parties acknowledge that each has had the unlimited right within
the law and the opportunity to make demands and proposals with respect to any matter deemed a
proper subject for collective bargaining. The results of this exercise of that right and opportunity are
set forth in this Agreement. Therefore, unless otherwise mutually agreed, the County and the Union,
for the duration of this Agreement, each agree to waive the right to oblige the other party to bargain
with respect to any subject or matter not specifically referred to or covered in this Agreement.

## 1 ARTICLE 4: HOLIDAYS

4.1 Holidays - Regular, probationary, provisional and term-limited temporary employees shall
be granted the following holidays with no loss of pay:

4.2 Day of Observance - For holidays falling on a Saturday, the Friday before shall be
observed as the holiday. For holidays falling on a Sunday, the Monday following shall be observed as
the holiday.

4.3 Personal Holidays - Personal holidays shall be administered through the vacation plan.

24 One (1) day shall be available for use on the first of October and one (1) day on the first of November
25 of each year. These days shall be used in the same manner as any vacation day earned.

#### 1 ARTICLE 5: VACATIONS

5.1 Accrual - Regular, probationary, provisional and term-limited temporary employees shall
 be eligible for vacation leave benefits as described in this Article except in those instances expressly
 provided:

5.1.1 Employees shall accrue vacation leave from their date of hire in a leave eligible

26 position.

5.1.2 Employees who are eligible for vacation leave and who work less than a full-time

28 || schedule shall receive pro-rated leave to reflect his/her normally scheduled workweek.

5.2 Payoff - Employees shall not be eligible to take or be paid for vacation leave until they 1 have successfully completed their first six (6) months of County service, and if they leave County 2 employment prior to successfully completing their first six (6) months of County service, shall forfeit 3 and not be paid for accrued vacation leave. Employees shall be paid for accrued vacation leave to 4 their date of separation up to the maximum accrual amount if they have successfully completed their 5 first six (6) months of County service. Payment shall be the accrued vacation leave multiplied by the 6 employee's regular rate of pay in effect upon the date of leaving County employment less mandatory 7 8 withholdings.

9 5.3 Scheduling - The manager/designee shall be responsible for establishing a vacation
10 schedule in such a manner as to achieve the most efficient functioning of the division.

5.4 Maximum Accrual - Employees may accrue up to sixty (60) days vacation pro-rated to
reflect their normally scheduled work-day. Employees shall use vacation leave beyond the maximum
accrual amount prior to December 31 of each year. Failure to use vacation leave beyond the
maximum accrual amount will result in forfeiture of the vacation leave beyond the maximum amount
unless the manager/designee has approved a carryover of such vacation leave because of cyclical
workloads, work assignments or other reasons as may be in the best interests of the County.

17 5.5 Use of Vacation - Employees shall not use or be paid for vacation leave until it has
18 accrued and such use or payment is consistent with the provisions of this Article.

19 5.5.1 No employee shall work for compensation for the County in any capacity during the
20 time that the employee is on vacation leave.

5.6 Separation - In cases of separation from County employment by death of an employee
with accrued vacation leave and who has successfully completed his/her first six (6) months of
County service, payment of unused vacation leave up to the maximum accrual amount shall be made
to the employee's estate, or, in applicable cases, as provided for by state law, RCW Title 11.

5.7 Reemployment - If a regular employee resigns from County employment or is laid off
and subsequently returns to County employment within two (2) years from such resignation or lay off,
as applicable, the employee's prior County service shall be counted in determining the vacation leave
accrual rate under Section 5.1.

#### ARTICLE 6: SICK LEAVE

6.1. Regular, probationary, provisional and term-limited temporary employees shall accrue
sick leave benefits at the rate of 0.04616 hours for each hour in pay status exclusive of overtime;
except that sick leave shall not begin to accrue until the first of the month following the month in
which the employee commenced employment. The employee is not entitled to sick leave if not
previously earned.

6.2. During the first six (6) months of service in a leave eligible position, employees may, at
the manager's/designee's discretion, use any accrued days of vacation leave as an extension of sick
leave. If an employee does not work a full six (6) months in a leave eligible position, any vacation
leave used for sick leave must be reimbursed to the County upon termination.

6.3. There shall be no limit to the hours of sick leave benefits accrued by an employee.

6.4. Separation from or termination of County employment except by reason of retirement or
layoff, shall cancel all sick leave accrued to the employee as of the date of separation or termination.
Should a regular or probationary (who has previously achieved career service status) employee resign
or be laid off and return to County employment within two (2) years, accrued sick leave shall be
restored.

6.5. Regular or probationary (who has previously achieved career service status) employees
who have successfully completed at least five (5) years of County service and who retire as a result of
length of service or who terminate by reason of death shall be paid, or their estates paid or as
provided for by RCW Title 11, as applicable, an amount equal to thirty-five percent (35%) of their
unused, accumulated sick leave multiplied by the employee's rate of pay in effect upon the date of
leaving County employment less mandatory withholdings.

6.6. Leave Without Pay for Health Reasons: An employee must use all of his/her sick
leave before taking unpaid leave for his/her own health reasons. If the injury is compensable under
the County's workers compensation program, then the employee has the option to augment or not
augment time loss payments with the use of accrued sick leave.

27 6.7. Leave Without Pay for Family Reason: For a leave for family reasons, the employee
28 will choose at the start of the leave whether the particular leave would be paid or unpaid; but, when

1	an employee chooses to take paid leave for family reasons s/he may set aside a reserve of up to eighty
2	(80) hours of accrued sick leave.
3	6.8. Use of Vacation Leave as Sick Leave: An employee who has exhausted all of his/her
4	sick leave may use accrued vacation leave before going on leave of absence without pay, if approved
5	by his/her manager/designee.
6	6.9. Use of Sick Leave: Accrued sick leave will be used for the following reasons:
7	6.9.1. The employee's bona fide illness or incapacitating injury; provided, that:
8	6.9.1.1. An employee who suffers an occupational illness or is injured on the
9	job may not simultaneously collect sick leave and worker's compensation payments in a total amount
10	greater than the net regular pay of the employee; though an employee who chooses not to augment
11	his/her worker's compensation time loss pay through the use of sick leave will be deemed on unpaid
12	leave status;
13	6.9.1.2. An employee who chooses to augment workers compensation
14	payments with the use of accrued sick leave will notify the workers compensation office in writing at
15	the beginning of the leave;
16	6.9.1.3. An employee may not collect sick leave and worker's compensation
17	time loss payments for physical incapacity due to any injury or occupational illness which is directly
18	traceable to employment other than with the County.
19	6.9.2. Exposure to contagious diseases and resulting quarantine.
20	6.9.3. A female employee's temporary disability caused by or contributed to by
21	pregnancy and childbirth.
22	6.9.4. The employee's medical, ocular or dental appointments, provided that the
23	employee's manager/designee has approved the scheduling of sick leave for such appointments.
24	6.9.5. To care for the employee's eligible child if the child has an illness or health
25	condition which requires treatment or supervision from the employee;
26	6.9.6. To care for other family members, if:
27	6.9.6.1. The employee has been employed by the County for twelve (12)
28	months or more and has worked a minimum of one thousand forty (1040) hours in the preceding

3	employee's child, a child of the employee's spouse or domestic partner, the parent of the employee,

6	6.9.6.3. The reason for the leave is one of the following:
7	6.9.6.3.1. The birth of a son or daughter and care of the newborn child,
8	or placement with the employee of a son or daughter for adoption or foster care, if the leave is taken
9	within twelve (12) months of the birth, adoption or placement;
10	6.9.6.3.2. The care of the employee's child or child of the employee's
11	spouse or domestic partner whose illness or health condition requires treatment or supervision by the

15	6.10. Unpaid Leave: An employee who has been employed by the County for twelve (12)
16	months or more and has worked a minimum of one thousand forty (1040) hours in the preceding
17	twelve (12) months, may take a total of up to eighteen (18) work weeks unpaid leave for his or her
18	own serious health condition, and for family reasons as provided in Sections 6.10.5 and 6.10.6
19	combined, within a twelve (12) month period. The leave may be continuous, which is consecutive
20	days or weeks, or intermittent, which is taken in whole or partial days as needed. Intermittent leave is
21	subject to the following conditions:
22	6.10.1. Birth or Adoption: When a leave is taken after the birth or placement of a
23	child for adoption or foster care, an employee may take leave intermittently or on a reduced leave
24	schedule only if authorized by the employee's manager/designee.
25	6.10.2. Reduced Schedules: An employee make take leave intermittently or on a
26	reduced schedule when medically necessary due to a serious health condition of the employee or
27	family member of the employee; and
28	6.10.3. Temporary Transfer: If an employee requests intermittent leave or leave

13	6.10.6.2. A position with equivalent status, benefits, pay and other terms and
14	conditions of employment; and
15	6.10.6.3. The same seniority accrued before the date on which the leave
16	commenced.
17	6.10.7. Failure to Return to Work: Failure to return to work by the expiration date
18	of the leave of absence may be cause for removal and result in termination of the employee from
19	County service.
20	6.11. Provider Certification: The manager/designee and employee is responsible for the
21	proper administration of the sick leave benefit. Verification from a licensed health care provider may
22	be reasonably required to substantiate the health condition of the employee or family member for
23	leave requests.
24	6.12. Definition of Child: For purposes of this Article, a child means a biological, adopted
25	or foster child, a step child, a legal ward or a child of an employee standing in loco parentis to the
26	child, who is: under eighteen (18) years of age; or is eighteen (18) years of age or older and incapable
<b>27</b> -	of self care because of mental or physical disability.

20	section if the employee belongs to a group that has voted to implement a voluntary employee
21	beneficiary association plan and the employee fails to execute forms that are necessary to the proper
22	administration of the plan within twelve months of retirement by reason of length of service, as
23	defined in subsection 1 of this subsection.

#### ARTICLE 7: PAID LEAVES

#### 7.1 Donation of Leaves

#### 7.1.1 Vacation leave hours

A. Approval Required - An employee eligible for paid leave may donate a portion of
his/her accrued vacation leave to another employee eligible for leave benefits. Such donation will
occur upon written request to and approval of the donating and receiving employee's department
director(s), except that requests for vacation donation made for the purposes of supplementing the
sick leave benefits of the receiving employee will not be denied unless approval would result in a
departmental hardship for the receiving department.

B. Limitations - The number of hours donated will not exceed the donor's accrued
vacation credit as of the date of the request. No donation of vacation hours will be permitted where it
would cause the employee receiving the transfer to exceed his/her maximum vacation accrual.

C. Return of Unused Donations - Donated vacation leave hours must be used within
ninety (90) calendar days following the date of donation. Donated hours not used within ninety (90)
days or due to the death of the receiving employee will revert to the donor. Donated vacation leave
hours will be excluded from vacation leave payoff provisions contained in this Article. For purposes
of this Article, the first hours used by an employee will be accrued vacation leave hours.

7.1.2 Sick leave hours.

A. Written Notice Required - An employee eligible for paid leave may donate a
portion of his/her accrued sick leave to another employee eligible for leave benefits upon written
notice to the donating and receiving employee's department director(s).

B. Minimum Leave Balance Required (Donor) - No donation will be permitted
unless the donating employee's sick leave accrual balance immediately subsequent to the donation is
one hundred (100) hours or more. No employee may donate more than twenty-five (25) hours of
his/her accrued sick leave in a calendar year.

C. Return of Unused Donations - Donated sick leave hours must be used within ninety (90) calendar days. Donated hours not used within ninety (90) days or due to the death of the receiving employee will revert to the donor. Donated sick leave hours will be excluded from the

sick leave payoff provisions contained in this Agreement, and sick leave restoration provisions 1 contained in this Agreement. For purposes of this Article, the first hours used by an employee will be 2 accrued sick leave hours. 3

7.1.3 No Solicitation - All donations of vacation and sick leave made under this Article are 4 strictly voluntary. An employee is prohibited from soliciting, offering or receiving monetary or any 5 other compensation or benefits in exchange for donating vacation or sick leave hours. 6

7.1.4 Conversion Rate - All vacation and sick leave hours donated will be converted to a 7 dollar value based on the donor's straight time hourly rate at the time of donation. Such dollar value 8 will then be divided by the receiving employee's hourly rate to determine the actual number of hours 9 received. Unused donated vacation and sick leave will be reconverted based on the donor's straight 10 11 time hourly rate at the time of reconversion.

7.2 Leave - Organ Donors - The manager/designee will allow an employee eligible for paid 12 leave who is voluntarily participating as a donor in life-giving or life-saving procedures such as, but 13 not limited to, bone marrow transplants, kidney transplants, or blood transfusions up to five (5) days 14 paid leave provided; 15

7.2.1 Notification - The employee gives the manager/designee reasonable advance notice of 16 the need to take time off from work for the donation of bone marrow, a kidney, or other organs or 17 tissue where there is a reasonable expectation that the employee's failure to donate may result in 18 serious illness, injury, pain or the eventual death of the identified recipient. 19

7.2.2 Provider Certification - The employee provides written proof from an accredited  $\mathbf{20}$ medical institution, organization or individual as to the need for the employee to donate bone marrow, 21 a kidney, or other organs or tissue or to participate in any other medical procedure where the 22 participation of the donor is unique or critical to a successful outcome. 23

7.2.3 Time off Subject to Agreement - Time off from work for the purpose set out above in 24 excess of five (5) working days will be subject to the terms of this Agreement. 25

7.3 Bereavement Leave

7.3.1 An employee eligible for paid leave will be entitled to three (3) working days of bereavement leave a year, per occurrence, due to death of a member of his/her immediate family. 28

7.3.2 Use of Sick Leave in Lieu of Bereavement Leave - An employee eligible for leave
 who has exhausted his/her bereavement leave, will be entitled to use sick leave in the amount of three
 (3) working days for each instance when death occurs to a member of the employee's immediate
 family.

7.3.3 In the application of any of the foregoing provisions, when a holiday or regular day off
falls within the prescribed period of absence, it will not be charged against the employee's sick leave
account nor bereavement leave credit.

8 7.3.4 Family Defined - Immediate family means, as used in this Article: spouse, domestic
9 partner, grandparent, parent, child, sibling, child-in-law, parent-in-law, grandchild of the employee,
10 employee's spouse or employee's domestic partner.

7.4 School Volunteers - An employee eligible for paid leave will be allowed the use of up to
three (3) days of sick leave each year to allow the employee to perform volunteer services at the
school attended by the employee's child; provided, an employee requesting to use sick leave for this
purpose will submit such request in writing specifying the name of the school and the nature of the
volunteer services to be performed.

7.5 Jury Duty - An employee eligible for paid leave who is ordered on a jury will be entitled
to his/her regular County pay; provided, that fees for such jury duty are deposited, exclusive of
mileage, with the Finance & Business Operations Division of the Department of Executive Services.
The employee will report back to their manager/designee when dismissed from jury service.

7.6 Leave Examinations - An employee eligible for paid leave will be entitled to necessary
time off with pay for the purpose of participating in County qualifying or promotional examinations.
This will include time required to complete any required interviews.

7.7 Military Leave - A leave of absence for active military duty or active military training duty
will be granted to eligible employees in accordance with applicable provisions of state and/or federal
law; provided, that a request for such leave shall be submitted to the manager/designee in writing by the
employee and accompanied by a validated copy of military orders ordering such active duty or active
training duty.

1	ARTICLE 8: MEDICAL, DENTAL & LIFE INSURANCE
2	8.1 The County presently participates in group medical, dental and life insurance programs.
3	The County agrees to maintain the level of benefits as currently provided by these plans and pay
4	premiums as currently practiced, during the life of this Agreement unless modified by the Joint
5	Labor/Management Insurance Committee.
6	8.2 The County agrees to continue the Joint Labor-Management Insurance Committee
7	comprised of representatives from the County and its labor unions. The function of the Committee
8	shall be to review, study and make recommendations relative to existing medical, dental and life
9	insurance programs.
10	8.3 The Union and County agree to incorporate changes to employee insurance benefits
11	which the County may implement as a result of the agreement of the Joint Labor-Management
12	Insurance Committee referenced in Section 8.2 above.

#### ARTICLE 9: WAGE RATES

9.1 COLA - Effective January 1, of each year of the Agreement (years 2008, 2009 and 2010),
the base wage rates for employees shall be increased by 90% of the CPI-W All Cities Index
(September to September) with a maximum increase of six (6) percent but not less than two (2)
percent.

9.2 Step Movement/Merit - Employees covered by this Agreement shall be subject to the
County's ten step plan (truncated) and merit system as provided under KCC 3.15.020, as amended.

8 9.3 Professional Registration – To encourage and support professional development and to
 9 provide for the employment of qualified personnel in appropriate classifications, the County will
 10 provide compensation for professional licenses and certifications according to the following formula:

If the employee is required to hold the license/certification for her/his job, compensation shall
be paid at an additional one hundred dollars (\$100.00) per month. If the license/certification is not
required but is related to the employee's work, they will receive an additional fifty dollars (\$50.00)
per month. It is understood that the employee is responsible for costs and fees of obtaining and
renewing such licenses.

Applicable designations or professional licenses: Washington State professional license in the
branches of Civil, Electrical, Hydraulic, Industrial, Mechanical, Metallurgical, Sanitary, Structural,
Architectural, Land Surveying, Geology or Illumination; a registered architect's license or a
professional designation of CPA, MAI, RM, SSA, CPM or SR/WA; International Conference of
Building Officials Certifications in Building Inspection, Landscape Architecture, Certified Floodplain
Manager, Mechanical, Plumbing, Combination Inspector, Fire and Plans Examiner.

#### ARTICLE 10: HOURS OF WORK

2 10.1 Schedules - The establishment of work schedules is vested solely within the purview of
3 the County and may be changed from time to time. It is the policy of the County to actively promote
4 alternative and flexible work schedules.

10.2 FLSA - Employees covered by this bargaining unit are employed in a bona fide
executive, administrative or professional capacity and are in turn exempt from overtime payments
under the Federal Fair Labor Standards Act. Bargaining unit employees shall be covered under the
King County Executive Leave Pay and Leave Practices for Executive Administration and
Professional Employees policy (Executive Policy PER 8-1-1) and modifications thereto, and are
expected to work the hours necessary to satisfactorily perform their jobs.

11 10.2.1 Regular employees will receive at least three (3) days of Executive Leave during the
12 calendar year provided the employee is in an eligible position on January 1.

#### **ARTICLE 11: CONFLICT RESOLUTION**

11.1 The Union and the County recognize the importance of settling issues in a fair and 2 responsible manner at the lowest possible level of supervision and to use conflict resolution methods 3 whenever possible. 4

11.2 Grievance Definition - An issue raised by an employee regarding the interpretation 5 and/or application of the express written terms of this Agreement. A grievance, to be timely, must be 6 7 presented in writing to the employee's supervisor within ten (10) workdays of the occurrence or the employee's knowledge of the event. The grievance must contain a description of the event, when the 8 event took place and/or when the employee had knowledge of the event, the Articles allegedly 9 10 violated, and the remedy sought.

11

#### 11.3 Grievance Steps

11.3.1 Division Manager - The Manager shall have fifteen (15) workdays from the receipt of 12 the grievance to address the issue with the employee. The supervisor shall respond to the grievance 13 in writing within fifteen (15) workdays following the meeting with the employee. If the grievance is 14 not resolved, it may be referred in writing within ten (10) workdays following the date of the 15 Manager's written response to the Director of the Human Resources Division (HRD)/designee. If 16 the grievance is not pursued to the Director of HRD/designee within the ten (10) workdays, it shall be 17 presumed resolved. 18

11.3.2 Director of HRD - The director/designee will have thirty (30) workdays from receipt 19 20 of the grievance to address the issue with the employee. The director/designee shall respond to the grievance in writing within fifteen (15) workdays following the meeting with the employee. If the 21 grievance is not resolved, it may be referred in writing within ten (10) workdays following the date of 22 the director/designee's written response to mediation/arbitration. If the grievance is not pursued to 23 mediation/arbitration within ten (10) workdays, it will be presumed resolved. 24

25

11.3.3 Mediation/Arbitration - Mediation shall be the last step for grievances that are not timely. The Director of HRD/designee and the Union shall select a third disinterested party to serve 26 as the mediator/arbitrator. In the event they are unable to agree, then the mediator/arbitrator shall be 27 selected from a list of at least seven (7) names furnished by the Federal Mediation and Conciliation 28

Service (FMCS) or American Arbitration Association (AAA), whichever source is mutually 1 acceptable. The mediator/arbitrator shall be selected from the list by each party alternately striking a 2 name from the list until one name remains. The Union shall have the first strike from the list and the 3 parties will rotate the first strike for each grievance. The mediation process will proceed with the 4 parties making a good faith attempt to reconcile their differences. A mediated grievance, if timely, 5 will move to the arbitration phase only after the mediator and one of the two parties to the dispute 6 declare impasse. A formal arbitration hearing on timely grievances can be held at the request of 7 either party without going through the mediation process. The mediator cannot serve as the arbitrator. 8

9 11.4 The arbitrator shall have no power to change, alter, detract from, or add to the provisions
10 of this Agreement, but shall have the power only to apply and interpret the provisions of this written
11 Agreement in reaching a decision on the issue.

12 11.5 No matter may be arbitrated which the County, by law, has no authority over or has no
13 authority to change.

14

11.6 There shall be no strikes, cessation of work or lockout during mediation or arbitration.

15 11.7 Each party to a mediation/arbitration proceeding shall bear the full costs of its
16 representatives, including legal representatives, and witnesses regardless of the outcome of the
17 mediation or arbitration. The mediator's/arbitrator's fees and expenses and any court reporter's fee
18 and expenses agreed to by the Union and the County shall be borne equally by both parties.

19 11.8 Exclusive Procedure - Selection of this conflict resolution procedure for the resolution
20 of a grievance shall preclude the use of any other procedure in resolving the matter at issue.

21

11.9 Time Limits - Time limits may be extended by written consent of the parties.

11.10 Unfair Labor Practice (ULP) -The parties agree that thirty (30) days prior to filing a
ULP complaint with the PERC, the complaining party will notify the other party, in writing, meet,
and make a good faith attempt to resolve the issue unless the deadline for filing with PERC would
otherwise pass.

26 11.11 Temporaries - Probationary, provisional, temporary and term-limited temporary
27 employees are employed at will and can not use the procedures of this Article to grieve or otherwise
28 appeal a job separation action of any kind.

#### ARTICLE 12: REDUCTION IN FORCE

12.1 Order of layoff - In the event of a reduction in force due to lack of work, lack of funds or considerations of efficiency, layoffs shall be by position. The positions to be laid-off shall be at the sole discretion of management. In lieu of laying off a regular employee, the Director of the HRD may reassign such employee to a comparable, vacant position, when the Director of HRD determines such reassignment to be in the best interest of the County.

7 12.1.1 The County will attempt to place a regular employee subject to layoff in accordance
8 with the County's Workforce Management Program, as amended.

9 12.2 Recall - A regular employee who is laid off will have recall rights to his/her previous
10 position for two years from the date of layoff. An employee retains his/her recall rights even if he/she
11 accepts another position with the County. An employee who is laid off shall forfeit his/her recall
12 rights if he/she refuses a recall.

12.2.1 Notice of Recall - An employee will have ten (10) days from the date the notice of
recall is sent by certified mail in which to notify the County of whether he/she will accept the
position. The County will consider the employee's failure to notify the County within ten (10) days
as a refusal; however, if the County determines that there are warranting circumstances, it may accept
a late notice from an employee. Notices will be in writing. It is the employee's responsibility to keep
the County informed of his/her current address.

19 12.2.2 Reinstatement - An employee recalled within two (2) years from the time of layoff
20 will have any forfeited sick leave accruals and seniority restored and adjusted for the period of layoff,
21 and vacation leave accrual rate restored.

1	ARTICLE 13: WORK OUTSIDE OF CLASSIFICATION
2	13.1 It is understood by the parties that an employee may be assigned in writing to perform
3	the preponderance of the duties of a higher classification by the division manager/designee.
4	13.2 An employee assigned in writing by his/her division manager/designee to a higher
5	classification will be paid at the first step of the range assigned to the higher classification or at a step
6	that most closely approximates five percent (5%) above the employee's salary prior to the
7	assignment, whichever is higher.
8	13.3 The County may assign an employee to perform the work of a higher classification for
9	up to a full workweek without additional compensation. If the employee is assigned to perform the
10	work of the higher classification for a full workweek or more the employee will be paid for all time
11	performing the work of the higher classification in accordance with Section 13.2.
12	13.4 If the employee is required to work out-of-class for more than sixty (60) days, the Union
13	may request a meeting for the sole purpose of clarifying why the employee is still working out-of-
14	class.

#### ARTICLE 14: UNION REPRESENTATION AND EMPLOYEE RIGHTS

#### 14.1 Union Representation

3 14.1.1 Authorized representatives of the Union may, after notifying the County official in
4 charge, visit the work location of employees covered by this Agreement at any reasonable time for the
5 purpose of member representation.

6 14.1.2 The Executive Director and/or Union Representative shall have the right to appoint
7 stewards. The Union shall provide the County with the names of stewards so appointed. The steward
8 will be allowed reasonable time during working hours to see that the provisions of the Agreements
9 are observed.

10 14.1.3 Written policies, rules, or directives affecting the terms and conditions of this
11 Agreement shall be provided to the Union upon request.

#### 14.2 Employee Rights

13 || 14.2.1 The County may reprimand, suspend, demote or discharge a regular employee for just
14 || cause.

15 14.2.2 If at any level the County determines to bring disciplinary action against an employee
16 for any reason, the employee shall be apprised of his/her rights of appeal and representation as
17 provided for in the Conflict Resolution procedures under Article 12 of this Agreement.

18 14.2.3 Members of the bargaining unit are entitled to meal compensation pursuant to King
19 County Code 3.24.080.

#### ARTICLE 15: MISCELLANEOUS

15.1 Drug Free Workplace - The Union agrees to comply with all applicable federal, state
and county regulations and ordinances with regard to the drug free workplace.

**15.2 Training -** The County recognizes the mutual benefit to be attained by affording training
opportunities to employees and shall provide information and access to training opportunities for its
employees, within budgeted appropriations. The training opportunities shall be guided by, but not
limited to the overall objectives of encouraging and motivating employees to improve their personal
capabilities in performance of specific tasks.

9 15.3 Equal Employment Opportunity - The County or the Union shall not unlawfully
10 discriminate in employment on the basis of race, color, religion, national origin, age, creed, marital
11 status, sex, sexual orientation or on the presence of a sensory, mental or physical disability. Parties to
12 agree to specific remedy language.

13 15.4 Bulletin Boards - The County agrees to permit the Union to post on County bulletin
14 boards announcement of meetings, election of officers, and any other Union material, providing there
15 is sufficient space, beyond what is required by the County for "normal" operations.

16 15.5 Biweekly Payroll – If during the life of this Agreement the Council or Executive adopts
17 a biweekly payroll plan, the parties agree to adopt the plan.

18 15.6. Employee Safety During Work Stoppages - No member of this bargaining unit shall
19 be required to cross a legal picket line sanctioned by the King County Labor Council (this section
20 does not apply to informational pickets). This section shall not apply in situations that pose an
21 imminent threat to structures or human health and/or safety. An employee encountering a picket line
22 during the course of her/his duties shall contact her/his supervisor for work instructions.

## ARTICLE 16: GENERAL PROVISIONS

16.1 Savings Clause - Should any part hereof or any provision herein contained be rendered
or declared invalid by reason of any existing or subsequently enacted state or federal legislation or by
any decree of a court of competent jurisdiction, such invalidation of such part or portions of this
Agreement shall not invalidate the remaining portions thereof; provided, however, upon such
invalidation, the parties agree to meet and negotiate such parts or provisions affected. The remaining
parts or provisions shall remain in full force and effect.

8 16.1.1 The County and the Union and the employees covered by this Agreement are governed
9 by applicable county ordinances, and said ordinances are paramount except where they conflict with a
10 provision of this Agreement.

11 16.2 Work Stoppages and Employer Protection - The County and the Union agree that the 12 public interest requires efficient and uninterrupted performance of all county services and to this end 13 pledge their best efforts to avoid or eliminate any conduct contrary to this objective. Specifically, the 14 Union shall not cause or condone any work stoppage, including any strike, slowdown, or refusal to 15 perform any customarily assigned duties, sick leave absence which is not bona fide, or other 16 interference with county functions by employees under this Agreement, and should same occur, the 17 Union agrees to take appropriate steps to end such interference. Any concerted action by any 18 employees in the Union shall be deemed a work stoppage if any of the above activities have occurred.

19 16.2.1 Any employee participation in such work stoppage or in other ways committing an act
20 prohibited in this Article shall be considered absent without authorized leave and shall be considered
21 to have resigned.

1	ARTICLE 17: DURATION		
2	17.1 This Agreement shall become effective upon full and final ratification and approval by		
3	all formal requisite means by the Council and shall be effective through December 31, 2010.		
4	17.2 Contract negotiations for the succeeding contract may be initiated by either party		
5	providing to the other written notice of its intention to do so prior to August 1, 2010.
