#### Ordinance 15603

AN ORDINANCE relating to the annexation of

**Proposed No.** 2006-0326.1

Sponsors Ferguson and Hague

2	approximately 15 acres of land, known as "The NE 197th
3	Place – 23rd Avenue NE Annexation," into the Ronald
4	Wastewater District, for the purpose of extending sewer
5	service.

8	STATEMENT OF FACTS:
9	1. A notice of intention proposing the annexation of approximately 15
10	acres of land into the Ronald Wastewater District for the purpose of
11	providing sanitary sewer service was filed with the county council on July
12	17, 2006.
13	2. Ronald Wastewater District approved the annexation of the area
14	according to RCW 57.24.170 in Resolution No. 06-18, passed on July11,
15	2006.
16	3. Ronald Wastewater District filed a determination of nonsignificance on
17	the proposed annexation dated June 12, 2006.

18	4. The utilities technical review committee recommended county council
19	approval of the proposed annexation.
20	5. The county council held the legally required public hearing and has
21	considered the criteria in RCW 57.02.040.
22	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
23	SECTION 1. The annexation of approximately 15 acres of land into Ronald
24	Wastewater District for the purpose of providing sanitary sewer service described in
25	Attachment A to this ordinance is approved. Approval of this proposed annexation is
26	consistent with RCW 57.02.040.
27	SECTION 2. Ronald Wastewater District is the appropriate entity to serve the
28	area proposed to be annexed.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications or actions necessary to provide service to this annexation area.

## LEGAL DESCRIPTION 23<sup>rd</sup> AVENUE NE AT BALLINGER ANNEXATION

BEGINNING AT A POINT ON THE SOUTH LINE OF THE NORTH HALF OF SECTION 4, TOWNSHIP 26 NORTH, RANGE 4 EAST, WM., INTERSECTING WITH THE CENTERLINE OF BALLINGER WAY NE;

THENCE NORTHWESTERLY ALONG THE CENTERLINE OF BALLINGER WAY NE TO THE WEST LINE OF THE EAST HALF OF THE NW QUARTER OF SAID SECTION 4;

THENCE SOUTH ALONG THE WEST LINE OF THE EAST HALF OF THE NORTHWEST QUARTER OF SAID SECTION 4 TO THE NORTHEAST MARGIN OF FOREST PARK DRIVE NE;

THENCE SOUTHEASTERLY ALONG THE NORTHEAST MARGIN OF FOREST PARK NE TO THE NORTH MARGIN OF NE 195<sup>TH</sup> PLACE;

THENCE NORTH 89° 18' 15" EAST ALONG THE NORTH MARGIN OF NE 195<sup>TH</sup> PLACE 175.77 FEET;

THENCE NORTH 2° 16' 58" WEST 310 FEET

THENCE NORTH 89° 18' 15" EAST 220.09 FEET;

THENCE SOUTH 2° 16' 58" EAST 150,00 FEET:

THENCE NORTH 89° 18' 15" EAST 75.00 FEET;

THENCE SOUTH 2° 16' 58" EAST 75.00 FEET;

THENCE NORTH 89°18' 15' EAST 138.11 FEET;

THENCE SOUTH 2° 05' 06" EAST 305.06 FEET TO THE SOUTH LINE OF THE NORTH MARGIN OF SAID SECTION 4;

THENCE EAST ALONG SOUTH LINE AND EXTENSION THEREOF TO THE POINT OF BEGINNING.
