1	AN ORDINANCE relating to the annexation of
. 2	approximately eighteen acres of land into the Southwest
3	Suburban Sewer District, known as the Cedarhurst Division
4	No. 3 (2006) Island Annexation, for the purpose of
5	providing sewer service.

8	STATEMENT OF FACTS:
9	1. A notice of intention proposing the annexation of approximately
10	eighteen acres of land into the Southwest Suburban Sewer District, known
11	as Cedarhurst Division No. 3 (2006) Island Annexation, for the purpose of
12	providing sewer service was filed with the county council on October 12,
13	2006.
14	2. Southwest Suburban Sewer District approved the annexation in
15	Resolution No. 2006-37, adopted on October 3, 2006.
16	3. Southwest Suburban Sewer District filed a Determination of
17	Nonsignificance on the proposed annexation dated September 7, 2006.

18	4. The utilities technical review committee recommended county council
19	approval of the proposed annexation.
20	5. The county council held the legally required public hearing and has
21	considered the criteria in RCW 57.02.040.
22	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
23	SECTION 1. The annexation of approximately eighteen acres of land into
24	Southwest Suburban Sewer District for the purpose of providing sewer service described
25	in Attachment A of this ordinance is approved. Approval of this proposed annexation is
26	consistent with RCW 57.02.040.
27	SECTION 2. Southwest Suburban Sewer District is the appropriate entity to
28	serve the area proposed to be annexed.

Island Annexation Cedarhurst Division No. 3 (2006) Legal Description

A portion of the southwest quarter of Section 8, Township 23 North, Range 4 East W.M. situated in King County, Washington, described as follows:

Beginning at the intersection of the easterly margin of State Highway No. 1-K (SR 509) with the centerline of South 128th Street;

Thence westerly along said centerline to its intersection with the east line of the west 208 feet of the south 305 feet of the southeast quarter of the southwest quarter of said Section 8;

Thence northerly along said east line to the north line thereof;

Thence westerly along said north line to the east line of the west 89 feet of the Southeast quarter of the southwest quarter of said Section 8;

Thence northerly along said east line to the centerline of South 124th Street;

Thence northeasterly along said centerline and its extension thereof to its intersection with the north line of the southeast quarter of the southwest quarter of said Section 8;

Thence easterly along said north line to an intersection with the easterly margin of State Highway 1-K;

Thence southwesterly along said easterly margin to the point of beginning.
