1	A MOTION authorizing the chair of the council to enter
2	into a contract for an independent consultant to provide
3	oversight of the construction of the Ninth and Jefferson
4	Building at Harborview Medical Center.

6	WHEREAS, the metropolitan King County council adopted the 2007 Budget
7	Ordinance, Ordinance 15652, appropriating funds for a pilot project within the King
8	County auditor's office to provide independent and expert oversight of King County's
9	major capital construction projects, and
10	WHEREAS, the King County auditor's office was mandated to manage the pilot
11	capital project oversight function and wishes to retain a consulting firm with expertise in
12	capital projects management and oversight, and
13	WHEREAS, the county's procurement services office issued a request for
14	proposals ("RFP") to provide oversight of the design and construction of the Ninth and
15	Jefferson Building, incorporating the requirements set out in Ordinance 15652, and
16	WHEREAS, an RFP evaluation committee, comprised of county council staff,
17	county auditor staff and county executive staff evaluated the proposals, conducted

18	interviews and unanimously determined that the proposal from Jones Lang LaSalle best
19	meets the selection criteria outlined in the RFP, and
20	WHEREAS, the county auditor also evaluated the consultants' proposals and
21	references, determined that Jones Lang LaSalle has the qualifications and expertise to
22	conduct this oversight project and recommends council approval of Jones Lang LaSalle,
23	and
24	WHEREAS, Motion 10651, Section III, as amended, and OR 1-020 requires the
25	council to authorize the council chair to sign any contracts in excess of twenty-five
26	thousand dollars in the legislative branch;
