1 A MOTION adopting the priorities of King County for the 2 2008 budget. 3 4 WHEREAS, under the King County charter, the county council is the policy 5 determining body and adopts budgets for King County government, and 6 WHEREAS, the executive under the charter carries out policy as set by the 7 council and presents budgets and a budget message setting forth the programs which he 8 proposes for the county during the next fiscal year, and 9 WHEREAS, the council has over the years provided policy direction to the 10 executive to be reflected in the proposed budget, including initiatives such as the office of 11 information resource management, the juvenile and adult justice operational master plans, 12 realignment of the district court system, expansion of drug and mental health courts. 13 development of framework policies for human services, establishment of the nearshore 14 habitat conservation initiative, creation of the cultural development authority, the 15 property expert review task force, the citizens election oversight committee, the county's annexation and children's health initiatives and the public health operational master plan, 16 17 and

18	WHEREAS, the council has been a leader in promoting performance management
19	in King County and adopted Motion 11561 in 2002 encouraging the executive to broaden
20	the use of performance measurement throughout county government as a way of
21	enhancing management of scarce resources and demonstrating accountability, and
22	WHEREAS, such priorities as efficiency, greater public trust and wise
23	management of scarce resources are valid both for agencies that receive general fund
24	revenues and agencies such as the road services division and the Transit Division that are
25	funded through revenues dedicated for specific purposes, and
26	WHEREAS, in October 2006, the council adopted Motion 12367 setting the
27	Priorities for People for the 2007 budget, and
28	WHEREAS, the Priorities for People included the major categories of earning
29	public trust, enhancing quality of life, and protecting human health and safety, and
30	WHEREAS, for 2007, the council took further steps to improve the efficiency and
31	effectiveness of King County government and to increase public trust by creating the
32	financial policies advisory task force, by appropriating funds in the budget to study the
33	creation of an office of economic and financial analysis, by funding the capital projects
34	oversight pilot project, by creating the office of law enforcement oversight, by initiating a
35	performance audit of the development and management of major capital projects, and by
36	undertaking a pilot biennial budgeting project, and
37	WHEREAS, to further the council's effort to adopt priorities that serve the people
38	of King County, the council initiated the citizen engagement project under which five
39	workshops, two public forums and an online survey were used to help the council
40	determine the priorities of our citizens for 2008 and thereafter, and

WHEREAS, the results of the citizen engagement project revealed that citizens	
ranked courts as a key to the working of the law, safety and justices programs of the	
county, that public health clinics serve a critical role in providing services to less	
fortunate and uninsured citizens in the county, that low-income housing and youth and	
family services are among the highest priorities in community health and human service	es
program areas, and that regional parks and open space are among the most important	
functions in the natural resources and environment program areas, and	
WHEREAS, the council has used the citizen input along with their other contac	:ts
with the people and their professional and leadership knowledge and abilities to develop	p
priorities for 2008;

# King County Budget Priorities for 2008 --Building on 2007 Priorities for People-Setting and Implementing the Council Vision

The Metropolitan King County Council provides fiscal integrity and accountability by setting spending priorities based on public expectations, funding programs consistent with those priorities, and measuring results. "Priorities for People" established three top priorities as standards for the County's 2007 budget. After a thorough citizen engagement initiative, the Council now establishes its vision for implementing those citizen priorities in the 2008 King County budget:

#### 1. Earn Public Trust:

- a. Implement sound County financial oversight measures and manage the public's money prudently and wisely.
- b. Increase citizen engagement in oversight of County services.
- c. Closely monitor and report on County spending.
- d. Further citizen involvement in setting budget priorities.
- e. Improve customer service.
- f. Guarantee the right to vote for all eligible King County residents, and ensure that voting systems are secure, reliable, and private.
- g. Establish additional County local and regional government performance measurements and publicly report on them.
- h. Increase accountability and transparency on capital projects.

### 2. Enhance Quality of Life:

- a. Manage growth wisely.
- b. Provide quality local government services.
- c. Improve transportation options and provide greater mobility for people, vehicles and freight.
- d. Reduce carbon emissions, maintain levees, enhance cleanup of Puget Sound waterways and take other measures for responsible environmental stewardship.
- e. Create and encourage vibrant cultural and recreational opportunities.

### 3. Protect Public Health and Safety:

- a. Enhance the County's capability and flexibility to meet needs for public health protection, promotion, and provision.
- b. Promote conditions for optimal physical and mental health and reduction in chemical dependency and obesity.
- c. Partner with organizations to ensure access to public health for the uninsured and the underinsured.
- d. Pursue programs to keep young citizens away from the criminal justice system.
- e. Continue to implement crime and gang activity reduction programs.
- f. Reduce the cost of detention while increasing effective and safe alternatives to jail detention.
- g. Prepare our citizens, neighborhoods and County government for natural disasters and public health emergencies.
- h. Implement measures for further oversight of the Sheriff's Office.
