SUBJECT

A motion approving the executive's response to a proviso in the 2007 Adopted Budget regarding staffing of the King County Animal Care and Control Citizen's Advisory Committee.

SUMMARY

Proposed Motion 2007-0369 approves the executives staffing plan for the Animal Care and Control Citizen's Advisory Committee. The staffing plan approves a .5 FTE position for the purpose of administrating the committee and other related duties.

BACKGROUND

The Animal Control Citizen's Advisory Committee (Advisory Committee) has not been active for a number of years. In the 2007 Adopted Budget, the council included the following proviso in the Records, Elections and Licensing Division's budget:

Of this appropriation, \$250,000 shall not be expended or encumbered until: (1) the executive has transmitted appointments to fill all vacancies on the King County animal control citizen's advisory committee, together with proposed confirmation motions and information on the appointees, and the council has confirmed all appointees; and (2) the executive has submitted and the council has reviewed and approved by motion, a plan for ongoing administrative support of the King County animal control citizen's advisory committee.

The proposed appointment motions, the plan for administrative support and the proposed motion approving the plan shall be submitted by the executive by April 15, 2007, in the form of 11 copies filed with the clerk of the council, who will retain the original and will forward a copy to each councilmember and to the lead staff of the labor, operations and technology committee, or its successor.

On April 13, 2007, the council received ten of the then eleven required appointments to the Advisory Committee.

On May 29, 2007, the council adopted Ordinance 15801 which, among other things, renamed the Animal Control Citizen's Advisory Committee the Animal Care and Control Citizen's Advisory Committee and revised the roles, responsibilities and composition of the committee as follows:

- The committee is to provide evaluation and recommendations for a model animal services program with specific focus on the prevention of animal cruelty, the humane care and welfare of animals in King County shelters, the reduction of euthanasia, the increase of adoptions and the strengthening of community partnerships and volunteer programs.
- The committee is to provide evaluation and recommendations on performance measures, funding, staffing levels and staffing needs, facilities and capital improvements.
- The committee is to produce an annual report to the executive and the council. The executive would then be responsible to review and make recommendations to the council based on the committee's report.
- The committee is to provide assistance with animal care and control's public information and education campaign.
- Two additional members were added to the committee to represent the Coalition for a No Kill King County and Friends of King County Animal Control

In sum, the committee was refocused to address animal welfare issues and the policies, procedures, resources and outreach needed to build a model program.

Also on May 29, 2007, the council adopted Motion 12521, requesting that the executive work in conjunction with the Advisory Committee to develop a special report on how the Animal Services Program (ASP) will become a model for the humane treatment of animals and reduce rates of euthanasia. The report was due to the council on August 31, 2007.

On September 9, 2007 the council approved the two appointees for the Coalition for a No Kill King County and Friends of King County Animal Control. At this time, the only outstanding appointment is the position for the Seattle-King County Veterinarian Medical Association (VMA).

ANALYSIS

On June 25th the executive transmitted the staffing plan for the Advisory Committee. The staffing plan, as attached to Proposed Motion 2007-0369 would include a .5 FTE to perform the following duties:

- Prepare analysis, research and report writing
- Public outreach to stakeholder groups, attendance at community meetings
- Perform administrative functions, prepare agendas, attend Advisory Committee meetings, evaluate committee processes

The executive requested funding for the .5 FTE via through the second quarter omnibus ordinance. That ordinance (15873), with the .5 FTE, was approved on July 23, 2007. The executive has stated that a budget request will be submitted as part of the 2008 budget cycle for on-going staff support to the committee.

The Advisory Committee held its first meeting on July 19, 2007 and has been meeting on a weekly basis to develop a report to the council and the executive per Motion 12521. In a letter dated August 10, 2007, the Advisory Committee requested an extension to the deadline for the report to September 24, 2007, to further develop recommendations for the council's consideration, due to the late date on which the Advisory Committee was first convened. The executive may need additional time beyond September 24th for further review of the Advisory Committee's recommendations prior to transmitting a final report to the council.

Approval of Proposed Motion 2007-0369 appears to support the objectives of the council to promote an active Advisory Committee. Because the staffing plan was not transmitted by the April 15th deadline, an amendment to the 2007 Adopted Budget will be necessary to release the \$250,000 in provisoed funds.

AMENDMENTS

Technical amendments have been prepared to correct references to the animal control program which were changed, per Ordinance 15801 to the animal care and control program. The amendment also removes language stating that King County has formed a model animal control program. The council has requested that the executive and advisory committee work to determine how King County might become a model program in the future.

Dear Councilmember Gossett:

I am pleased to transmit to the Metropolitan King County Council the staffing plan for the King County Animal Control Citizen's Advisory Committee and a motion proposing a plan for ongoing administrative support for the Committee.

The staffing plan is provided in response to Section 28 proviso two of Ordinance 15652:

Of this appropriation, \$250,000 shall not be expended or encumbered until: (1) the executive has transmitted appointments to fill all vacancies on the King County animal control citizen's advisory committee, together with proposed confirmation motions and information on the appointees, and the council has confirmed all appointees; and (2) the executive has submitted and the council has reviewed and approved by motion, a plan for ongoing administrative support of the King County animal control citizen's advisory committee.

Nominations for membership were provided to the council in April. Two additional positions were recently added to the committee via Ordinance 15801: a representative from Friends of King County Animal Control and a representative from the Coalition for a No Kill King County. Records, Elections and Licensing Services will contact these agencies for nominations, which will be forwarded for Council's consideration under separate cover.

King County is a recognized leader in the animal control and animal welfare field. In 1995, King County was the recipient of a National Association of Counties Achievement Award for its Model Animal Control Program. A good deal of the credit for this award should go to the King County Animal Control Citizen's Advisory Committee. The Committee, established by the King County Council by Ordinance 9464 in 1990, did a great deal of work in helping King County create its Model Animal Control Program. In recent years, the Committee stopped meeting, and each of the Committee positions became vacant.

King County's Animal Control Program has achieved a number of important results since the adoption of Ordinance 9464.

- In 1993, King County Animal Control euthanized 2,952 healthy adoptable pets, in addition to 6,080 unhealthy, unadoptable pets (1993 was the first year that the euthanasia of healthy, adoptable was tracked). In 2006, King County Animal Services euthanized no healthy, adoptable pets, and just 4,331 unhealthy, unadoptable pets. That euthanasia total for 2006 is an all-time low (since statistics were kept).
- In 1993, King County Animal Control adopted just 1,802 pets. In 2006, King County Animal Services adopted 4,525 pets.
- In 1990, King County issued 57,254 pet licenses (1990 was the first year pet licenses were tracked). In 2006, King County issued 139,442 pet licenses.

When it created the Animal Control Citizen's Advisory Committee, the King County Council gave the body a number of important tasks. These tasks were recently updated with the passage of Ordinance 15801. These tasks, as outlined in KCC 11.06.030, are as important today as they were in 1990:

- B. Following the initial report, the committee shall meet monthly to:
 - 1. Receive periodic reports from the animal care and control section;
 - 2. Advise the county executive and county council on all aspects of animal control and the welfare and safety of all animals;
 - 3. Assist the county executive and county council in the development of programs and policies concerning animal care and control;
 - 4. Review and comment on proposed animal care and control rules, policies, or ordinances before their adoption;
 - 5. Review the animal care and control section's progress in implementing adopted policies; and,
 - 6. Develop the annual repot to the King County executive and council.

In order to accomplish these goals in 2007, King County Animal Services requested a .5 FTE via a supplemental for the second quarter of 2007 to adequately establish administrative and staff support for the Committee through the remainder of the year. A budget request will be submitted as part of the 2008 budget cycle for on-going support of the committee in 2008 and beyond if funding has not already been included as part of the base 2008 budget.
