1	AN ORDINANCE ratifying and confirming in all respects
2	Ordinance 15883 that was introduced on July 16, 2007, and
3	adopted as amended by the metropolitan King County
4	council on July 30, 2007; and declaring an emergency.
5	
6	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
7	SECTION 1. Findings:
8	A. The Growth Management Act ("GMA"), Countywide Planning
9	Policies ("CPPs") and King County Comprehensive Plan ("KCCP") require the
10	delineation and protection of valuable and increasingly limited agricultural
11	resource lands and supports regulations that serve to encourage the continuation
12	of agriculture land uses.
13	B. King County has identified and designated a number of Agricultural
14	Production Districts including the Snoqualmie Valley Agricultural Production
15	District.
16	C. The Snoqualmie Valley Agricultural Production District, at fourteen
17	thousand five hundred eighty-one acres, is the single, largest agricultural

18	production district in King County and historically has had a very productive
19	agricultural industry.
20	D. The Snoqualmie Valley Agricultural Production District is regularly
21	inundated by flood waters and has experienced six of the eight largest flood
22	events on record in the last twenty-one years, with the likelihood of more-frequent
23	occurrences in the future.
24	E. These flood water levels are often increased by a number and variety
25	of factors, such as storm water from development on the uplands that drain into
26	the Snoqualmie valley.
27	F. The Snoqualmie Valley Agricultural Production District is distinct from the
28	other designated agricultural production districts of King County in that a significant
29	majority of the Snoqualmie Valley Agricultural Production District is located within the
30	one-hundred-year floodplain.
31	G. The regular occurrence of flooding has greatly impacted agriculture within the
32	Snoqualmie Valley Agricultural Production District due to the lack of elevated farm pads
33	that provide safe havens for farm animals and on which farm products, such as seeds,
34	flower bulbs, hay and similar products and farm equipment could be placed during a
35	flooding event.
36	H. In light of these facts, on July 30, 2007, the metropolitan King County
37	council adopted Ordinance 15883, on an emergency basis, to establish a
38	demonstration project, as authorized under K.C.C. chapter 21A.55, for the
39	emergency repair or reconfiguration of existing livestock flood sanctuaries or

40	converting existing livestock flood sanctuaries to farm flood pads within the
41	Snoqualmie Valley Agriculture Production District.
42	I. Ordinance 15883 was adopted as an interim official control under RCW
43	36.70A.390.
44	J. A question has arisen whether the process followed by the county in adopting
45	Ordinance 15883 was adequate to meet the requirements of RCW 36.70A.390. It is
46	therefore appropriate to adopt this ordinance ratifying and confirming Ordinance 15883
47	in order to address that concern and to clarify that Ordinance 15883 is valid and binding
48	in the county and that all work commenced under it, which complies with its
49	requirements and with all other applicable law, remains consistent with King County law.
50	K. Given the likelihood that future floods will increase in frequency and intensity
51	and in order to expedite the repair, reconstruction and expansion activities authorized by
52	Ordinance 15883 before the start of the next flood season, a waiver of state and county
53	public notice requirements is necessary and an emergency action by the council is
54	appropriate.
55	SECTION 2. Metropolitan King County council Ordinance 15883, establishing the
56	Livestock Flood Sanctuaries and Farm Flood Pads Demonstration Project, which
57	Ordinance is attached hereto as Attachment A to this ordinance and incorporated by
58	reference as if set out in full, is hereby ratified and confirmed in all respects.
59	SECTION 3. For the reasons set forth in section 1 of this ordinance, the county
60	council finds as a fact and declares that an emergency exists and that this ordinance is
61	necessary for the immediate preservation of public peace, healthy or safety or for the
62	support of county government and its existing public institutions.

- 63 <u>SECTION 4.</u> This ordinance is adopted as an interim official control under RCW
- 64 36.70A.390 and expires February 1, 2008.
