# Metropolitan King County Council Operating Budget, Fiscal Management and Select Issues Committee 2008 Work Program

#### 1. Amendments to 2008-09 Budget

Goal: Review and make recommendations to the full Council on all proposed ordinances amending the 2008-09 operating budget ordinance. Any requested changes for the Transit biennial budget will be reviewed in the context of a twenty-four month appropriation.

#### Key Work Program Items:

- Review up to four quarterly omnibus operating budget supplemental ordinances;
- Review "stand-alone" operating budget supplementals;
- Track and report on operating budget provisos and responses.

#### 2. Financial Analysis and Budget Monitoring

Goal: Review financial reports, budget reports, financial plans and other documents in order to track operating budget ordinance and policy compliance, financial conditions, operating results, reserve status, and other financial issues.

## Key Work Program Items:

- Review quarterly management and budget reports from Office of Management and Budget;
- Review other reports and documents in order to track financial condition of major funds.
- Review and identify best budget practices from other similar agencies with regard to budget:
  - o Development
  - o Reporting
  - Analysis

#### 3. Debt and Investment Proposals

Goal: Make policy recommendations to the full Council on proposals for the issuance of short or long-term debt and refunding of bonds related to operating budgets, and proposals for investment of public funds related to operating budgets.

## Key Work Program Items:

 Review and pass on to the full Council ordinances that authorize the issuance of new debt or the refunding of existing debt that are related to operations;

- Continue staffing the Council's Investment Pool Advisory Panel;
- Propose new investment policies as appropriate, based on recommendations of the Panel.

#### 4. Levies, Fees and Taxes

Goal: Make policy recommendations to the full Council on proposals to implement new fees, charges, levies or taxes or to change existing fees charges, levies or taxes related to operations.

#### Key Work Program Items:

Review of 2008/2009 sewer rate and capacity charge.

#### 5. Financial Policies

Goal: In accordance with recommendations of the Council's Financial Policies Advisory Task Force (FPATF), form Executive/Council Work Group to develop a comprehensive financial policy document.

#### Key Work Program Items:

- Regular update briefings for Committee, including progress towards completion;
- Final approval of a complete financial policies manual (after feedback from the FPATF);
- Staff level work groups to meet with executive branch staff on the project.

# 6. Office of Economic and Financial Analysis

Goal: Based on Business Plan developed by the Council's consultant, take necessary steps to create the Office of Economic and Financial Analysis.

# Key Work Program Items:

- Review Draft Business Plan in committee:
  - o Determine which option best meets the County's needs
    - Status quo
    - Council office technical review
    - Council office independent forecast
    - Joint office
- If Joint Office is selected
  - Reach agreement with the Executive on language to submit to Charter Review Commission
  - Select representatives for KC Forecast Council
  - Reach agreement with Executive on interim organization prior to Charter change

Develop contingency plan if Charter change fails

#### 7. Biennial Budgeting

Goal: Make policy recommendations to the full Council on any additional agencies/funds to be added to the list of biennial budget agencies for the 2009-2010 biennium.

#### Key Work Program Items:

- Brief the Committee on the 2007 process for adding Transit as a biennial budgeting agency. This briefing will include lessons learned and any issues that arose during the budget process.
- Discuss any potential agencies for biennial budgets for the 2009-2010 biennium.

#### 8. Mental Health

Goal: Make policy recommendations to the full Council on the Mental Health Implementation Plan for the new one-tenth of one cent sales tax.

#### Key Work Program Items:

- Review three-phase oversight, implementation and evaluation plan for the mental illness and drug dependency action plan.
  - o Part I is due April 1, 2008
  - o Part II is due June 1, 2008
  - o Part III is due August 1, 2008

# 9. Department of Justice's Report on the King County Correctional Facility

Goal: Make policy recommendations to the full Council on the Executive's response to the DOJ report, including additional funding if needed to implement changes.

## Key Work Program Items:

- Initial briefing by Directors of Adult & Juvenile Detention and Public Health
- Policy direction to Executive on steps needed to respond to DOJ
- · Propose supplemental budget for DAJD and Jail Health, as needed
- Oversee implementation of recommendations/reforms.
