




OBJECTIVES:

IMPACTED SERVICE AREA:



Golden Gardens, Shilshole, Ballard, Fremont

SERVICE CHANGE: Provide hourly midday service in both directions between Golden Gardens, Shilshole, Ballard and Fremont between approximately 9 am and 3 pm on weekdays. This new service was made possible through some administrative service adjustments in the west subarea.


IMPACTED SERVICE AREA:

OBJECTIVES:



Kent, Renton


SERVICE CHANGE:


Add 30-minute service from approximately 8:30 am and 3:00 pm on weekdays. Route 153 will operate under a Transit Now partnership, with a third of the midday cost being funded by the City of Kent and the City of Renton.

OBJECTIVES:

Add peak service between Lake Meridian Park-and-Ride and downtown Seattle via the Glencarin neighborhood and Southeast 208th/212th streets (*Service Strategy S-6, Transit Service in Rapidly Developing Areas, Strategic Plan for Public Transportation 2007-2016*); improve peak service coverage in Kent East Hill (*Implementation Strategy IM-1, Transit Now Program, Strategic Plan for Public Transportation 2007-2016*).

IMPACTED SERVICE AREA:

East Hill, Glencarin, North Meridian Park, Riverview, downtown Seattle.

SERVICE CHANGE:

Create new peak period, peak direction Route 157 serving Lake Meridian Park-and-Ride, Glencarin, East Hill, Riverview, and downtown Seattle.

On weekdays, operate three morning trips from Lake Meridian Park-and-Ride to downtown Seattle, and three afternoon trips from downtown Seattle to Lake Meridian Park-and-Ride.
