1	A MOTION approving the plan for construction of a
2	pedestrian pathway on Issaquah Fall City road.
3	
4	WHEREAS, the county is responsible for providing road services to the citizens
5	of unincorporated King County, and
6	WHEREAS, the county maintains a prioritized list of safety projects, and
7	WHEREAS, Ordinance 15975, the ordinance adopting the 2008 King County
8	budget, contains a proviso requiring the transportation director's office to submit to the
9	council for its review and approval, a plan to construct a pedestrian walkway on the
10	Issaquah Fall-City Road from the Pacific Cascade Freshman Campus School to Klahanie
11	SE/252nd Avenue SE, and
12	WHEREAS, the executive has transmitted to the council with this motion, a plan
13	for the pathway, developed collaboratively by the department of transportation's road
14	services division and the Issaquah school district, and
15	WHEREAS, the road services division has proposed to implement additional
16	improvements during the summer of 2008 to be in effect prior to the start of the 2008-
17	2009 school year, including installation of a real-time driver feedback electronic reader

18	board powered by solar recharged batteries and installation of edge-line rumble strips
19	along the outside marked edge of the westbound travel lane between 247th Place SE and
20	Klahanie Drive SE, and
21	WHEREAS, the county and the Issaquah school district agree that if a grant
22	application to the Washington state Department of Transportation is unsuccessful, the
23	\$500,000 available for improvements shall be expended prior to September 1, 2009 on a
24	scaled-down set of pedestrian pathway improvements in this corridor;
25	NOW, THEREFORE, BE IT MOVED by the Council of King County:
26	The plan to construct a pedestrian walkway from the Pacific Cascade Freshman
27	Campus School to Klahanie SE/252nd Avenue SE., Attachment A to this motion, is
28	hereby approved.

The county council supports the road services division's plan to implement
additional improvements during the summer of 2008.

King County Department of Transportation Road Services Division Plan for Construction of Issaquah Fall City Road Pedestrian Pathway

Ordinance 15975, Section 110 DOT DIRECTOR'S OFFICE, Proviso P1

Of this appropriation, \$500,000 shall not be expended or encumbered until the council reviews and accepts by motion, a plan to construct a pedestrian walkway from the Pacific Cascade Freshman Campus School to Klahanie SE/252nd Avenue SE. The plan shall include a description of the scope of work, an itemized engineer's estimate, and a schedule that indicates project completion in 2008 or substantive reasoning as to why the project cannot be completed in 2008. Under any scenario, the project schedule shall indicate a completion date not later than June 30, 2009. If the report is not filed by April 1, 2008, the appropriation authority for the \$500,000 restricted by this proviso shall lapse.

The plan required to be submitted by this proviso must be filed in the form of 11 copies with the clerk of the council, who will retain the original and will forward copies to each councilmember and to the transportation committee, or its successor.

Scope of Work

Widening of Issaquah Fall City Road to permit construction of 1,700 feet of new pedestrian pathway on the north side of the Issaquah-Fall City Road between 247 PL SE and Klahanie Dr SE. Additional safety treatments include pedestrian lighting, the addition of pedestrian signal countdown timers and activation upgrades to existing traffic signals, as well as upgrades to traffic signs, signals and pavement markings within the project limits

Rationale for Schedule

The Road Services Division (RSD) constructs school pathways during the summer months in order that construction activities and heavy equipment do not interfere with access to schools, or cause potential safety hazards for student pedestrians, school buses and general school traffic, during operating periods. In order to secure complete funding for this expanded project scope RSD and the Issaquah School District must obtain approval of the requested grant funds. Preliminary notification of the grant application status will be provided by the Washington State Department of Transportation in November 2008. Construction of the pathway would occur in summer 2009 and be completed by August 31, 2009, prior to the opening of the middle school's 2009-2010 school year.
