administration of functions related to the mental illness and drug dependency fund. No other amount of this appropriation shall be expended or encumbered until the council receives and approves by motion a three-phased oversight, implementation and evaluation plan for the mental illness and drug dependency action plan.

The office of management and budget, the departments of community and human services, public health and adult and juvenile detention, the superior court, the district court, the prosecuting attorney, the public defender and the sheriff are requested, with assistance from council staff, to develop and submit for council review and approval a three-phased oversight, implementation and evaluation plan for the mental illness and drug dependency action plan as specified in Ordinance 15949.

Part I of the oversight, implementation and evaluation plan shall be submitted to the council by April 1, 2008, for council review and approval by motion. Part II of the oversight, implementation and evaluation plan shall be submitted to the council by ((June 1, 2008,)) July 3, 2008 for council review and approval by motion. Part III of the oversight, implementation and evaluation plan shall be submitted to the council by August 1, 2008, for council review and approval by motion.

Eleven copies of each plan to the council shall be filed with the clerk of the

council, who will retain the original and will forward copies to each councilmember and to the lead staff the law, justice and human services committee, or its successors.

Ordinance 16154 was introduced on 6/9/2008 and passed by the Metropolitan King County Council on 6/23/2008, by the following vote:
