6                   WHEREAS, the metropolitan King County council and the King County  
7                   executive have worked together through their respective government relations staff and  
8                   desire to bring their positions on issues facing the 2009 Washington state Legislature to  
9                   the attention of the Washington state Legislature, and

10                  WHEREAS, King County desires to work cooperatively with other local  
11                  governments and other organizations, such as the Washington State Association of  
12                  Counties, the Washington Association of County Officials, the Suburban Cities  
13                  Association and the Association of Washington Cities, to achieve its 2009 legislative  
14                  goals, and

15                  WHEREAS, counties have been recognized by the Legislature as partners with  
16                  the state in the delivery of such critical services as transportation, criminal justice, public  
17                  health, community and human services and water resources, and

18           WHEREAS, King County is dependent on a strong fiscal partnership with the  
19        state, and

20           WHEREAS, King County's general fund suffers from a structural imbalance  
21        between the limited revenue authorities and the growth rate of expenditures, and

22           WHEREAS, the deepening national recession has resulted in dramatic budget  
23        shortfalls at all levels of government across the nation, and

24           WHEREAS, the dramatic downturn of the economy has magnified the general  
25        fund's structural problem as forecast sales tax and interest earnings deteriorate and the  
26        cost of providing services increases due to rising inflation, and

27           WHEREAS, counties currently have a limited number of options to ask local  
28        voters for additional resources for specific county services, and

29           WHEREAS, if King County is going to be able to continue delivering basic  
30        government services to our residents, it needs new flexibility and revenue tools from the  
31        state, and

32           WHEREAS, King County is dedicated to exploring with the state new ideas for  
33        sustained funding for critical services such as transportation, public safety, and public  
34        health, and

35           WHEREAS, the King County council and the King County executive will  
36        continue to review legislative developments for possible revisions of King County's 2009  
37        state legislative program, and

38           WHEREAS, by Motion 12909 the metropolitan King County council adopted  
39        King County's 2009 State Legislative Agenda, which was Attachment A to Motion  
40        12909, and

41           WHEREAS, in item number 13 of Attachment A to Motion 12909, "District  
42       Court," not "Judicial Administration," should have been listed as the applicable  
43       "Department," and

44           WHEREAS, a corrected version of Attachment A to Motion 12909 is attached to  
45       this motion as Attachment A, and

46           WHEREAS, Attachment A to this motion differs from Attachment A to Motion  
47       12909 only in the listing of "District Court" as the applicable "Department" in item  
48       number 13, and

49           WHEREAS, although the King County 2009 Statement of State Policy was  
50       Attachment B to Motion 12909, it was not referred to and explicitly adopted in the text of  
51       the motion, and

52           WHEREAS, Attachment B to this motion is identical to Attachment B to Motion  
53       12909;

54           NOW, THEREFORE, BE IT MOVED by the Council of King County:


