

1	AN ORDINANCE relating to road names; changing the
2	name of a portion of Southeast 300th Street to Southeast
3	Falcon Way.

5	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
6	SECTION 1. The roadway presently known as Southeast 300th Street, located in
7	the SW 1/4 of Section 4, Township 21 North, Range 6 East, W.M. as depicted in the plat
8	of Kentlake Highlands Division 1B, recording # 20060620000259 and described as
9	follows: beginning at the southern point of 219th Avenue Southeast adjacent to the
10	northern corner of parcel 0421069011, thence southwesterly to a point midway on the
11	northern edge of parcel 0421069106, thence westerly to the end of the roadway at the
. 12	western boundary of parcel 0421069087, is hereby redesignated as Southeast Falcon Way
13	as shown in the map on Attachment A to this ordinance.
14	SECTION 2. Notice of the proposed name change has been provided to the
15	affected property owners as required by K.C.C. 16.08.020.
16	SECTION 3. The director of the department of transportation shall accomplish
17	any necessary sign changes within sixty days of the effective date of this ordinance

services shall accomplish any necessary address change notifications within seventy days	
of the effective date of this ordinance.	
SECTION 5. Any necessary address changes shall be effective ninety days	
following the effective date of this ordinance.
