## Ordinance 16617

Proposed No. 2009-0417.2 Sponsors Hague

1	AN ORDINANCE establishing November 3, 2009, as the	
2	date of a special election on the question of annexation to	
3	the city of Kirkland of an unincorporated area known as the	
4	Finn Hill, Kingsgate and North Juanita annexation area; the	
5	proposition shall be placed on the November 3, 2009, ballot	
6	by the King County elections director only if there is no	
7	appeal filed from the July 9, 2009, decision of the boundary	
8	review board approving this annexation; and declaring an	
9	emergency.	
10		
11	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:	
12	<u>SECTION 1.</u> Findings:	
13	A. The city of Kirkland, Washington, by Resolution No. R-4763, has determined	
14	that it is in the public interest and general welfare to provide for the annexation of an area	
15	known as the Finn Hill, Kingsgate and North Juanita annexation area, in accordance with	
16	chapter 35A.14 RCW.

17	B. City of Kirkland Resolution No. R-4763 satisfies the provisions of chapter	
18	35A.14 RCW for qualification for annexation.	
19	C. The city of Kirkland, by Resolution No. R-4751 initiated the annexation of the	
20	Finn Hill, Kingsgate and North Juanita annexation area.	
21	D. The King County boundary review board received a request for review under	
22	chapter 36.93 RCW, and on July 9, 2009, the review board, in file 2293, deemed the	
23	proposed city of Kirkland Finn Hill, Kingsgate and North Juanita annexation file	
24	approved.	
25	E. Pursuant to chapters 29A.04 and 35A.14 RCW, the metropolitan King County	
26	council deems an emergency exists for the purpose of calling a special election to be held	
27	on the question of this annexation on November 3, 2009.	
28	SECTION 2. A special election shall be held on the 3rd day of November 2009	
29	in accordance with chapter 35A.14 RCW within the territory of the proposed annexation,	
30	for the purpose of submitting the question of annexation of the Finn Hill, Kingsgate and	
31	North Juanita annexation area.	
32	SECTION 3. The number of registered voters within the subject area is estimated	
33	at 19,730 as nearly as may be determined from available records.	
34	SECTION 4. Pursuant to RCW 29A.04.321 and 35A.14.050, it is hereby deemed	
35	that an emergency exists for purposes of calling a special election. The King County	
36	elections director is hereby requested to assume jurisdiction to call and conduct a special	
37	election and submit to the registered voters within the subject area of the proposition as	
38	set forth in section 4 of this ordinance. The clerk of the council is hereby authorized and	
39	directed to transmit the proposition to the elections director in substantially the following

40	form, with such additions, deletions or modifications in the ballot title as may be required		
41	for the propositions listed below by the King County prosecutor:		
42	PROPOSITION 1:		
43	Shall the area of unincorporated King County known as the Finn Hill, Kingsgate		
44	and North Juanita Annexation Area, described in Resolution R-4751, be annexed		
45	to the city of Kirkland and subject to zoning as provided in Ordinance 4196, and		
46	shall all property within the area annexed be assessed and taxed at the same rate		
47	and on the same basis as property within the city of Kirkland to pay for the		
48	outstanding indebtedness of the city?		
49	For annexation, adoption of zoning regulations and assumption of		
50	indebtedness.		
51	Against annexation, adoption of zoning regulations and assumption of		
52	indebtedness.		
53	SECTION 5. The elections director is hereby authorized and requested to prepare		
54	and distribute a local voters' pamphlet, pursuant to K.C.C. 1.10.010, for the special		
55	election called for in this ordinance, the cost of the pamphlet to be included as part of the		
56	cost of the special election.		
57	SECTION 6. The boundaries of the territory proposed for annexation are hereby		
58	described in city of Kirkland Resolution No. R-4763 as contained in Attachment A to this		
59	ordinance.		
60	SECTION 7. RCW 29A.32.280 provides that for each measure from a		
61	jurisdiction that is included in a local voters' pamphlet, the legislative authority of that		
62	jurisdiction shall formally appoint a committee to prepare arguments advocating voter

63	approval of the measure and a committee to prepare arguments advocating voter rejection		
64	of the measure.		
65	SECTION 8. In accordance with RCW 29A.32.280, the following individuals are		
66	appointed to serve on the voters' pamphlet committees, each committee to write a		
67	statement for or against the proposed annexation ballot measure:

72	SECTION 9. Contingency. The proposition shall be placed on the November 3,		
73	2009 ballot by the King County elections director only if there is no appeal filed by		
74	August 10, 2009 from the July 9, 2009, decision of the boundary review board approving		
75	this annexation.		
76	SECTION 10. The council fi	nds as a fact and declares that an emergency exists

- and that this ordinance is necessary for the immediate preservation of public peace, health
- 79 or safety or for the support of county government and its existing public institutions.
