

- Metro Transit



Green River Evacuation Routes



General Approach

- Promote use of evacuation routes
- Maintain mobility as long as possible
- Use common signage to avoid confusion
- Use collection sites for the transit dependent
- Ensure safety with timely road closures
- Respond to special requests as needed



Dear Green River Valley Resident:

The purpose of this visit is to let you and your family know that the area where you live has been identified as a high risk area for flooding due to damage found to the abutment of the Howard Hanson Dam. The Army Corps of Engineers is working on repairs for may not be able to hold back water to the dam's full capacity this winter. The King County Sheriff's Office and King County Fire District 44 - Mountain View Fire and Rescue would like to partner with you to help you plan, prepare for and respond to any flooding that may occur in your area.

Our deputies and firefighters would like to work with you to help you complete a simple survey. It will help them keep you, your family, livestock and pets safe if flooding is expected and you need to evacuate. This information will help us to plan with you and ensure we have accurate ways to communicate with you in case of an emergency. Please make a copy of the survey for your records and provide us with any updates to your information at the email addresses or telephone numbers provided below. If you like, we will send you a copy of your completed survey.

We strongly encourage you to buy flood insurance, prepare a family plan, compile a "no go" kit for you, your family and pets, and stay connected to emergency messages by signing up for automatic emergency alerts. You can receive these alerts on your phone, home computer or personal communications device. You should also have a battery powered radio and batteries. Be prepared for possible power outages by having flashlights and a supply of non-perishable food on hand.

The following website will help you prepare for receiving alerts, purchasing flood insurance, and preparing for a flood. Other tips for staying safe are provided. This information is available in several languages.



Coordination Meetings

- KC ESF 6 Planning Team – meets weekly to develop KC ESF 6 Plan and coordination of inclusion of operational plan and coordinate local, state and federal roles and responsibilities.
- County/State/FEMA ESF 6 Team – meets weekly to existing plans.
- Regional Green River Planning Team – meets every two weeks, includes emergency managers of impacted jurisdictions. Coordination point for cities to be briefed on the KC Government status.



General Notes

- Final plan will include an all-hazard scalable plan for sizes of a few hundred to a few thousand citizens.
- Site locations are being identified and MOU/Contracts are being put in place.
