#### **SUBJECT**

A MOTION authorizing the chair of the council to amend the existing contract for services with the Ferguson Group to represent the county during the 2010 United States 111th Congress, 2nd session.

#### **SUMMARY**

Since 1997, The Ferguson Group has represented King County before the U.S. Congress on a wide range of issues. Their current contract, T02793T, expires on December 31, 2009, but may be renewed for an additional year. Proposed Motion 2009-0595 (Attachment 1, pp. 3-7 of these materials) would renew the existing contract to represent King County during the 2009 United States 111<sup>th</sup> Congress, <sup>2nd</sup> Session.

Documentation attached to this staff report includes a letter from The Ferguson Group Partner, Bill Hanka, dated October 14, 2009, requesting that King County extend the existing contract T02793T for 2010 calendar year (Attachment 2, pp. 7-8 of these materials). His letter documents the accomplishments made by The Ferguson Group on behalf of King County. Also included is The Ferguson Group Activity Report August - September 2009 detailing the status of the FY 2010 Federal Legislative Agenda (Attachment 3, pp. 9-14 of these materials).

The Ferguson Group has been very successful in its representation of King County, working with our congressional delegation to obtain \$262 million in federal funding over the past ten years (\$16,067,020 in FY 2008). Attached is a table showing the results for FY 2005 through FY 2009 and the pending interim list for FY 2010 (Attachment 4, p. 15 of these materials). Our long standing relationship with The Ferguson Group has allowed them to understand the County's issues and priorities, and their successful track record reflects this knowledge and understanding. The high quality work performed by The Ferguson Group has been recognized by our Congressional Delegation, as well as by Councilmembers and the King County Executive.

The Ferguson Group Issue Team for King County now includes three partners and one principal. The amount of this amendment 2 is \$258,000 making the total amount of the contract \$774,000.

The FY 2011 Federal Legislative Agenda is currently being prepared. Since Congress has delayed final action on many items on the FY 2010 agenda, the FY 2010 results and FY 2011 Proposed Federal Agenda will be brought to the Council for review at a later date.

Dear Chair Constantine and Executive Triplett:

On behalf of The Ferguson Group, LLC (TFG) and its King County team (Bill Hanka, Christina Mattar, Kareem Murphy, Shirley Speidell, and Ron Hamm), I am writing to request that you renew our contract agreement to provide federal government services for King County. Working together we have built a strong foundation for consistently securing substantial levels of federal funding, as well as influencing legislative policy.

During the 13 years that TFG has represented King County in Washington, D.C., we have worked with the County and its congressional delegation to secure more than \$271 million in federally-designated funds. The figure does not reflect the significant financial benefits to the County as a result of the impact we have had on broader legislation and regulatory matters, nor does it include at least \$14 million for projects on the County's FY 2010 federal agenda, which is currently pending before Congress. The FY 2010 appropriations process is not yet complete and is expected to remain unfinished until later this year.

TFG develops and implements, in cooperation with King County elected officials and staff, strategies on all lobbying efforts to successfully move your federal agenda and action plan. We prepare all briefing materials, letters and talking points for federal and local legislators; meet with Members of Congress and their staff, as well as federal agency officials, to promote King County, and work with national coalitions to promote policies beneficial to King County. TFG organizes and arranges for meetings for King County elected officials and staff in Washington, D.C., with key decision makers, accompanies County representatives to these meetings and ensures that the appropriate follow-up is handled accordingly. We also provide regular verbal and written reports to keep the County attuned to the status of its agenda, as well as to new

legislation and policies of interest to the County. These are just a few of the services that TFG provides that enable King County to maintain an aggressive federal presence. TFG also provides in its contract with the County the use of the eCivis grants database, which has been used by many King County staff members to successfully apply for federal and non-governmental grants. During 2009 to date, King County users have logged on to eCivis 983 times and have viewed 1,979 grant opportunities.

In 2007, The Ferguson Group was very grateful to have been chosen to remain as your federal representative after a competitive rebidding process. We feel that this was a vote of confidence for how we do business and we thank you for the opportunity to continue to represent King County. TFG has a proven record of success as King County's federal lobbyist and remains committed to seeking out new ways to provide the County with the highest quality of service. We appreciate your time and consideration.

The Ferguson Group Activity Report August - September 2009

#### Latest Results on King County's Fiscal Year 2010 Federal Agenda

During August and September 2009, The Ferguson Group continued its advocacy on behalf of the County's Fiscal Year (FY) 2010 federal agenda. [Note: Congress was in recess for the month of August.]

The new federal fiscal year, FY 2010, began on October 1. To date, Congress has completed work on only one of the twelve annual appropriations bills, the bill funding the Legislative Branch, which the President signed on October 1. In order to prevent a government shutdown, Congress attached a Continuing Resolution to the Legislative Branch Appropriations bill that permits federal agencies to operate at the FY 2009 level until October 31, 2009.

When Congress adjourned for its traditional August recess on August 5, the House of Representatives had passed all 12 of the annual appropriations bills. However, the Senate had only approved the Legislative Branch, Homeland Security, Energy and Water Development, and Agriculture bills. Since Labor Day, the Senate has completed work on the Transportation-HUD and Interior-EPA bills and is currently considering its Defense bill. Following Defense Appropriations will be Commerce-Justice-Science and Military Construction. The Senate must also consider Financial Services, Labor-HHS-Education and State-Foreign Operations.

#### Visit of Mr. Chuck Williams to Washington, D.C.

On September 8-11, Mr. Chuck Williams traveled to Washington, D.C. to meet with the County's Congressional delegation to discuss the status of the County's FY 2010 agenda and urgent County matters, including emergency funding for the repair of the Howard Hanson Dam abutments and the Green River levees.

The Ferguson Group arranged and participated in meetings for Mr. Williams regarding all of the projects and issues on the County's agenda, including meetings with staff members in the following offices: Senator Murray, Sen. Cantwell, Congressman McDermott, Congressman Reichert, and Congressman Smith.

#### FY 2011 Agenda Meetings in King County

On September 14-15, The Ferguson Group (TFG) traveled to King County to meet with Councilmembers and County staff to begin work on the Fiscal Year 2011 federal agenda. TFG is preparing the first draft of the federal agenda and will send it to the Council and Executive staff by mid-October for their review and comment. In all of the meetings, TFG was accompanied by Chuck Williams, Tom Bristow, Lorrie McKay, and Carmela Ennis.

#### OFFICE OF THE SHERIFF

TFG met with the Sheriff's staff to discuss the status of the projects on the Sheriff's FY 2010 federal agenda and to discuss the projects for the FY 2011 agenda, including the School Resource Officers Project, the Gang Intervention Initiative Project, and the Community E-Policing Technology Project.

#### DEPARTMENT OF TRANSPORTATION

TFG met with the Department of Transportation staff to discuss the status of transportation projects on the FY 2010 agenda, the upcoming reauthorization of federal surface transportation programs (currently known as the "SAFETEA-LU" legislation) and the pending TIGER grant program. For FY 2011, new projects were discussed, including the Aurora RapidRide, Ballard-Uptown RapidRide and West Seattle RapidRide projects, a transit on board closed-circuit television project, the Alvord T Bridge Removal Project; the Berrydale Overcrossing project, the Woodinville-Duval/Avondale ITS Project, and the KCIA Snow Removal Equipment Project.

#### PUBLIC HEALTH

TFG met with Public Health staff to discuss the following issues: the reauthorization of the Ryan White HIV/AIDS Treatment and Modernization Act and the Child Nutrition and WIC legislation, supporting the Prevention and Public Health Fund, and supporting National Prevention and Wellness priorities.

#### DEPARTMENT OF NATURAL RESOURCES AND PARKS

TFG met with the Natural Resources and Parks staff, to discuss the status of the FY 2010 federal agenda. For FY 2011, the projects that were discussed include: the Pacific Coastal Salmon Recovery program, Puget Sound recovery funding, funding for the Duwamish/Green and Puget Sound Nearshore projects, North Bend floodplain buyouts, improved flood conveyance at the S.R. 202 Bridge, and the pending endangered species listing for kokanee salmon.

#### DEPARTMENT OF COMMUNITY AND HUMAN SERVICES

TFG met with Community and Human Services staff to discuss the status of the FY 2010 federal agenda and key federal programs, including the Community Development Block Grant (CDBG) program, the HOME Investment Partnerships program, the McKinney/Vento Homeless Assistance program and the Shelter Plus Care program, the Section 8 program, the Section 811 Supportive Housing for Persons with Disabilities program, the housing foreclosure assistance legislation, the 10-Year Plan to End Homelessness in King County, the Workforce Investment Act and mental health issues.

#### MEETING WITH SUPERIOR COURT

TFG met with Superior Court staff to discuss the status of the FY 2010 defendant tracking project, funding for riot control at the juvenile facility and a pending FY 2010 Byrne Grant application.
