1 AN ORDINANCE approving and adopting the updated
2 Multi-Jurisdictional Regional Hazard Mitigation Plan, as
3 approved by the Federal Emergency Management Agency.

5 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

6 SECTION 1. Findings:

7 A. King County supports disaster mitigation efforts and regional disaster
8 planning.

9 B. A locally adopted plan reviewed and approved by Federal Emergency
10 Management Agency ("FEMA") is required under the Mitigation Act of 2000, 44 C.F.R.
11 201.

12 C. Regular revisions and updates to the updated five year plan are required by
13 FEMA.

14 D. In October 2004, the King County council approved the county's initial five
15 year Multi-Jurisdictional Regional Hazard Mitigation Plan.

16 E. An updated plan is now required to comply with the Mitigation Act of 2000.

17 F. King County and other jurisdictions within King County have a cooperative
18 interest in disaster mitigation planning efforts.

19 G. Additional agencies are expected to annex to this plan following FEMA
20 approval.

21 H. FEMA approval of this plan enables the county to seek Federal mitigation
22 project funding related to potential flooding or other hazards the region may experience
23 over the next five year planning period.

24 I. Certification of the King County council's approval of this plan is required for
25 FEMA final approval.

26 SECTION 2. The King County council hereby approves and adopts the Multi-
27 Jurisdictional Regional Hazard Mitigation Plan, Attachment A to this ordinance.

28 SECTION 3. The King County council authorizes the office of emergency
29

30 management to make any required FEMA revisions to updated Multi-Jurisdictional
31 Regional Hazard Mitigation Plan required by FEMA final approval.




