This staff report is identical to the staff report dated 7 December 2009, except that it has been updated to reflect the December 7 committee hearing.

It is expected that Proposed Motion 2009-0618 will be reported out of the Committee of the Whole on December 14 without recommendation, will be expedited to the afternoon Council agenda, and then, after being amended to include the name of the appointee, will be voted upon at the Council meeting.

#### SUMMARY

Proposed Motion 2009-0618 (pp. 5-6 of these materials) would appoint a councilmember to represent Council District 8 until a successor is elected in the 2010 primary and general elections.

### BACKGROUND

On November 24 Councilmember Dow Constantine became King County Executive, thereby creating a vacancy in the seat representing Council District 8.

Section 680.10 of the King County Charter provides in part:

A vacancy in an elective county office shall be filled at the next primary and general elections which occur in the county; . . .

A majority of the county council may temporarily fill a vacancy by appointment until the vacancy has been filled by election or the successor to the office has been elected and qualified.

### **REVIEW PROCESS**

### Motion 13093

As authorized in Charter section 680.10, the Council by Motion 13093 (pp. 7-11 of these materials) invited interested candidates to submit applications for the vacant Council seat, established an advisory committee of community leaders who live or work in Council District 8, and directed the advisory committee to recommend three to six qualified applicants for the Council's consideration. The Council specified that the recommended candidates should include

at least one who did not intend to run for election to the office and at least one who did intend to run, assuming qualified candidates applied who met those criteria.

# **Council District Eight Advisory Committee**

The Advisory Committee reviewed the written materials submitted by each candidate, interviewed each candidate, and extensively discussed the candidates' qualifications. The committee unanimously recommended four candidates for the Council's consideration. As directed by the Council in Motion 13093, the committee did not rank the candidates, but did list what the committee deemed to be each candidate's particular strengths. A copy of the committee's recommendation is included in these materials at pp. 15-18. The Advisory Committee co-chairs briefed the Committee of the Whole on December 7.

# THE RECOMMENDED CANDIDATES

The recommended candidates, including their strengths as identified by the Advisory Committee, are listed below in alphabetical order:

Motion 13093 explicitly provides, at lines 70-71 (p. 10 of these materials), that the recommendation of the Advisory Committee "shall not limit the council's authority under the King County Charter to appoint any citizen who meets the qualifications for office."

## INTERVIEWS OF THE RECOMMENDED CANDIDATES

The committee is expected to report Proposed Motion 2009-0618 out of committee on December 14 without recommendation. Final action on the motion is expected at the Council's meeting that afternoon.

A MOTION recommending nominees for consideration by the Metropolitan King County Council for appointment to serve as County Councilmember representing Council District Eight until the November 2010 election.

WHEREAS, the Metropolitan King County Council by Motion 13093 established an advisory committee to review the nominees for appointment as County Councilmember representing Council District Eight to fill the vacancy caused by the election of Councilmember Dow Constantine as County Executive; and

WHEREAS, the Advisory Committee has reviewed the materials provided by the clerk of the Council, which included the information submitted by the nominees; has interviewed the nominees; and has discussed their qualifications; and

WHEREAS, as directed by the Council, the criteria that the Advisory Committee has used in evaluating the nominees have included those specified in Motion 13093; and

Dear Anne Levinson and Mark Okazaki,

I am interested in being considered for the appointment to fill the vacancy to represent MKC Council District Eight. If I am appointed to serve, I would do so as a caretaker, with no intention of running for election to the position.

This is an exceptionally difficult period for government and we face many challenges during this financial crisis - balancing budgets, preparing for economic recovery, moving forward with transportation solutions, dealing with gang violence and public safety, and emergency management, preparing for an influenza epidemic and potential catastrophic floods. I have experience in several of these areas and I would like to help MKCC find solutions to the challenges facing us.

1. Knowledge of the functions of King County government.

King County government is one of the largest regional governments in the U.S., serving nearly 2 million citizens. It is a complex, complicated government which provides both regional services including elections, public health, criminal justice and jails, public transit, sewage disposal, and parks, as well as local services to unincorporated King County, including land use and permitting.

I have served for 16 years on the Seattle City Council during which time I chaired the Finance and Budget Committee for four years, the Land Use Committee for four years, the Transportation Committee for the past four years, and have served on the Regional Transit Committee for more than four years. I know the current transportation issues and challenges that we face. As a community leader prior to serving on Seattle City Council, I was very involved with the criminal justice system focusing on crime prevention and gang violence. I have also served several years on the City Council's Public Safety Committee. I think that my experience and back ground have more than prepared me to serve on MKCC.

2. Knowledge of the issues and challenges facing King County government.

I believe the major issue facing King County government is the fiscal crisis. The County Council must look at both the revenue and the expenditure sides of the budget. As a former small business owner on Seattle City Council, I focused my efforts on the revenue side - job creation and economic development in the downtown revitalization, South Downtown, and South Lake Union.

Transportation is another huge challenge with more people moving into King County creating more demand as more people want to use public transit and while declining revenues make it difficult to meet that demand. The County Council must find a balanced way to serve transit riders in unincorporated King County, suburban cities and urban Seattle. We are finally moving forward with transportation solutions including Sound Transit, a replacement for the Alaskan Way Viaduct, and Bus Rapid Ride, and we must continue this momentum.

Public safety is another challenge, especially the issue of gang violence. I have been involved with criminal justice, public safety and gang violence issues for the past 25 years. I think that there are new and innovative ways to find solutions in this area.

King County government also faces challenges preparing for influenza epidemic and preparing for floods, especially the possibility of catastrophic flooding in the Green River Valley.

3. Knowledge of the issues affecting the constituents of Council District Eight.

Residents of Council District Eight face unique transportation challenges, especially during the construction of the Alaskan Way Viaduct project. I led the Seattle City Council to prioritize and find full funding for the South Spokane Street Viaduct project so it would be completed before the construction of the AWV project. I have also been a strong advocate for water transit, including the West Seattle Water Taxi and the Vashon Island ferry.

District Eight also includes the Duwamish industrial manufacturing area where there are many challenging issues including transportation and job retention and expansion.

4. A demonstrated ability to develop a responsible budget.

I have served for 16 years on the Seattle City Council Budget Committee, including four years as its chair. During the period of my chairmanship, I worked to make the budget process more transparent and to increase citizen participation through outreach. The current City budget is nearly \$4 billion, including the utilities - Seattle City Light and Seattle Public Utilities. The general fund budget is \$903 million. I have served during three economic down turns as well when the revenues were higher than projected. During the good times we prioritized major maintenance in capital projects and putting money into our stabilization (rainy day) fund to prepare for the economic down turns and funding one time only projects instead of hiring more employees. During the down turns we prioritized funding public safety and human services.

5. A demonstrated ability to respond to public concerns.

I replaced George Benson on the Seattle City Council who was well known for his constituent response. From the beginning my staff and I have worked hard to follow his example. We responded to constituent phone calls, correspondence and emails as quickly as possible and helped citizens to solve their problems by working with the relevant departments. We also worked with stakeholders early in the process of developing legislation as well as considering their suggestions presented at public comment periods, public workshops, forums and hearings. One example of responding to public concerns was establishing off-leash areas for dogs in Seattle. This issue came from the citizens and was very controversial, facing much opposition from the Parks Board. But I saw this as a problem with a solution. My staff and I worked for three years and involved over 15,000 people before the legislation was passed establishing six pilot areas which later became permanent. Today Seattle has 12 off-leash areas.

6. Demonstrated leadership skills.

I have served two two-year terms as Seattle City Council President, the first during my rookie term, and the second during the latter half of Mayor Greg Nickels' first term. The Council

President not only presides over Council meetings, but also is the department head with many additional responsibilities including personnel, management and communications. The position also carries considerable protocol responsibilities.

In my first term, I led the council in the revitalization of downtown, including the expansion of the Convention Center, working with Mayor Norm Rice to get the Council votes needed. I also brokered the compromise to pass the Comprehensive Plan. I was a founding member of the Labor Management Leadership Committee and served as a co-chair for many years. For most of my tenure, I have been involved in developing the Civic Center complex serving on the client committee to buy Key Tower to convert to the Seattle Municipal Tower, selling our historic Arctic and Alaska buildings, building the new Justice Center and City Hall buildings, and to develop the Civic Plaza. For the past four years, I have been the City Council's lead for the Alaskan Way Viaduct project, the South Lake Union Streetcar, Bridging the Gap levy and other transportation projects.

I have also served for 12 years on the Puget Sound Regional Council. I have served for several years, including the past four, on the Regional Transit Committee. I have developed good working relationships with elected officials at every level - local, regional, state and federal. Today partnerships are more important than ever and good relationships lead to good partnerships.

I look forward to a new experience serving a diverse district and helping to find solutions to issues and challenges. Thank you for your consideration for the appointment to fill the vacancy and for the opportunity to serve.

Thank you very much for your volunteer time in this selection process. Too often the role of dedicated individuals is overlooked when it comes to the effectiveness and functioning of our government. I very much appreciate your time in looking at my application materials and for your consideration. I hope that you will contact me or one of my attached references if you have any questions about my application. I would be honored to be appointed to serve the people of King County in the vacated, open County Council seat for District 8.

I am currently serving the people of the 11<sup>th</sup> Legislative District which includes parts of South Seattle, Tukwila, Renton, Seatac, Burien, and unincorporated King County. I was first elected in November 2002 after winning a five way primary. I am serving in my fourth term. I have been elected onto our House leadership team by my caucus peers each term I have served in Olympia. I am now serving our caucus as the Majority Floor Leader where I help organize all of the debate and schedule for the House of Representatives floor action. I also lead our caucus discussions of bills before they come up for floor votes. I have served on budget committees each of my seven years in Olympia (Transportation and General Government Appropriations), which means being part of the process for developing and passing a balanced budget. I have worked across the partisan divide on a number of issues – most recently and often as Floor Leader working with the Republican minority to make sure they are given enough time during floor debate; and also as the ranking Democrat on the House Committee on Environmental Health where I worked with the Republican chair of the committee and minority members to get some very controversial bills out of committee unanimously. I am proud of my work for the 11<sup>th</sup>.

I have also served in leadership roles outside of the legislature. I have managed political campaigns and managed staff members. I led a team to The Hague for Amazon.com to set up a contact center there that supported French, UK and German customer service operations. And most recently I was elected as board President for the Friends of the VA Puget Sound Fisher House, which serves veterans families while vets are in the VA hospital on Beacon Hill.

My service in the State Legislature, accompanied by the input from all of the meetings, events, town halls, emails, phone calls and letters has taught me about the concerns facing people in a district that was once referred to as the place where American dreams were formed. No matter how you define diversity, it is seen in my community. I represent urban, suburban, and almost rural communities. I reach out to the largest industrial business community in the state where over two billion dollars of payroll a year and 200,000 vehicle trips a day are made in the Duwamish area. There are over 100 languages spoken in the school districts of the 11<sup>th</sup>, with some schools having free and reduced lunch enrollments passing the 90% mark. I have taken a leadership role working on shoreline issues and super fund clean up sites along the Duwamish river. The 11th includes the King County airfield and the Seattle sex offender confinement facility and numerous other government agencies that affect everyday lives. I reach out and work with as many individuals and groups as I can to provide them with information, help and leadership on the issues they face. I try to answer all the calls that come into my legislative office. I'd be happy to talk with you more about the thousands of hours of constituent work out of my legislative office for the people of my district. I believe it is critical for any public official to stay in touch with issues facing regular people to understand how government is affecting their lives. For example, I recently worked with a toothless refugee woman who only received an OK for bottom teeth replacement from DSHS and wanted top teeth too. I also worked with a child care and education facility to ensure kids received mandated lead screening that wasn't being done. I bring up these constituency cases because I believe it is so important to listen and learn about new issues that come up and be an activist for my communities and their concerns.

King County government faces many specific issues like the Howard Hansen dam, the South Park Bridge, and basic service provisions for unincorporated areas like Skyway, White Center and Fairwood. The county is in transition in many ways as its role of local government service provider shrinks. As areas continue to incorporate or be annexed into cities, under GMA, that role will give way to the new and larger role of King County as a regional leader. Regional issues like the water treatment facility, jails, public health, and metro services are going to be the future of our county government. If you add in standard issues that go across district lines such as affordable housing, economic development, immigrant concerns, parks, transportation, crime and protection of our quality of life the county faces some serious challenges. All of this comes together in a budget crunch that is hitting every government and business in the country right now. I feel my background, my current knowledge and willingness to learn and serve will help the council tackle these tough issues with respect and concern for those involved.

We were asked to make a statement on our intention to run or not for the open District 8 seat in the 2010 elections. Having not made a decision on the issue, I am not prepared to declare my intentions to run at this time. I am very much inclined to run for the position, but will not make an official decision and declaration until after I am either appointed to serve in the vacated seat, or until after the upcoming 2010 legislative session. Being newly married, I am weighing the cost of a campaign on my new family.

I would very much like your support to move my name to the King County Council for consideration to fill the vacated open seat from District 8. I am happy to answer any questions about my background, the issues I see as important to the district and county and the functions of county government. I look forward to hearing from you. I do however have to mention that I am currently traveling in India and will not return home to Tukwila until after Thanksgiving. I am here with the American Council of Young Political Leaders. I am available after Dec 1, or with a pre-scheduled phone call. I have listed some references for your consideration below. I respectfully submit my name for consideration for appointment to represent District 8 on the King County Council once a vacancy occurs following the certification of the General Election. As a life-long resident of District 8 and having represented the 34<sup>th</sup> Legislative District in the Washington State Legislature for the past 9 years, I am well prepared to represent the 8<sup>th</sup> Council District.

I am well aware of the challenges King County faces and have unique experience to bring in finding solutions. The 6 years I spent working in the Pierce County Prosecuting Attorney's office gave me great insight into the criminal justice system. With criminal justice services making up approximately 70 percent of King County's general fund budget, knowledge of programs successful in not only saving money but producing positive outcomes, such as drug court, mental health court, and family court, will serve me well. My 4 years as a Senior Budget Analyst for the Seattle School District allowed me to work with principals and program managers across the district to develop responsible budgets for individual programs and the school district as a whole. This work experience is underscored by my service on the House Appropriations Committee and the Senate Ways & Means Committee, where I have made valuable contributions towards responsible budgets.

While the structural budget gap will continue to be a key issue for King County, other immediate concerns include addressing the potential flooding of the Green River until the Howard Hanson Dam is fully repaired, completing the tunnels servicing the Brightwater sewage treatment plant, and Metro Transit's budget shortfall. In my career in public service I have always taken up complex issues such as these and brought people together to solutions.

While King County faces many challenges, District 8 also faces specific issues. In the coming year, the Council will review the Shorelines Master Plan, which is critical to District 8 and Vashon and Maury Islands as over half of the undeveloped shorelines in King County are within this district. My personal knowledge of the unique value of this

shoreline developed over the last 9 years representing the 34<sup>th</sup> District in Olympia and will contribute to meaningful review in 2010.

The South Park Bridge is at risk for closure in 2010, with the federal government ranking it at 4 points out of 100 for safety. This vital transportation link carries more than 10 million tons of freight a year and 2,600 trucks daily and serves a high-employment area with approximately 32,000 jobs within one mile. The bridge is a lifeline to a low-income and multi-ethnic community, with 76 percent of businesses in South Park minority owned and 56 percent of South Park residents members of minority groups. Closure would reroute 20,000 vehicles daily onto an already taxed transportation system. I championed efforts to secure federal TIGER Stimulus funds for this essential project and would bring this advocacy to the Council.

When Washington State Ferries could no longer support passenger-only ferry service, I worked with King County to transfer this service to the county. I am vested in the King County Ferry District's success in linking West Seattle and Vashon with downtown Seattle and in exploring future routes as well.

I am convinced, given the pressing needs of King County, and District 8 in particular, that the person the Council appoints to this vacancy must have deep knowledge and expertise on the issues facing the County and District. Thus I believe the Councilmember should have the quality of skills that would be of ongoing service to the position and make themselves accountable by standing for election in the 2010 elections for this Council position. If appointed, I fully intend to run for the position in 2010.

Serving in the House of Representatives for 7 years and in the Senate for the past two allowed me to develop a keen ability to respond to and address public concerns, and also to develop a collaborative leadership style. I will work with each of you to further understand your priorities and districts and will work with you to achieve mutual success for our constituents and King County as a whole.

I look forward to interviewing with the Advisory Committee and the Council's Committee of the Whole to further discuss my interest in the position and experience that prepares me to serve on the King County Council.

#### Jan Drago

"King County government is one of the largest regional governments in the U.S., serving nearly 2 million citizens. It is a complex, complicated government which provides both regional services including elections, public health, criminal justice and jails, public transit, sewage disposal, and parks, as well as local services to unincorporated King County, including land use and permitting.

"I have served for 16 years on the Seattle City Council during which time I chaired the Finance and Budget Committee for four years, the land Use Committee for four years, the Transportation Committee for the past four years, and have served on the Regional Transit Committee for more than four years. I know the current transportation issues and challenges that we face. As a community leader prior to serving on Seattle City Council, I was very involved with the criminal justice system focusing on crime prevention and gang violence. I have also served several years on the City Council's Public Safety Committee. I think that my experience and back ground have more than prepared me to serve on MKCC."

# Knowledge of issues and challenges facing King County government

#### Jan Drago

"I believe the major issue facing King County government is the fiscal crisis. The County Council must look at both the revenue and the expenditure sides of the budget. As a former small business owner on Seattle City Council, I focused my efforts on the revenue side - job creation and economic development in the downtown revitalization, South Downtown, and South Lake Union.

"Transportation is another huge challenge with more people moving into King County creating more demand as more people want to use public transit and while declining revenues make it difficult to meet that demand. The County Council must find a balanced way to serve transit riders in unincorporated King County, suburban cities and urban Seattle. We are finally moving forward with transportation solutions including Sound Transit, a replacement for the Alaskan Way *Viaduct*, and Bus Rapid Ride, and we must continue this momentum.

"Public safety is another challenge, especially the issue of gang violence. I have been involved with criminal justice, public safety and gang violence issues for the past 25 years. I think that there are new and innovative ways to find solutions in this area.

"King County government also faces challenges preparing for influenza epidemic and preparing for floods, especially the possibility of catastrophic flooding in the Green River Valley."

## Zack Hudgins

"King County government faces many specific issues like the Howard Hansen dam, the South Park Bridge, and basic service provisions for unincorporated areas like Skyway, White Center and Fairwood. The county is in transition in many ways as its role of local government service provider shrinks. As areas continue to incorporate or be annexed into cities, under GMA, that role will give way to the new and larger role of King County as a regional leader. Regional issues like the water treatment facility, jails, public health, and metro services are going to be the future of our county government. If you add in standard issues that go across district lines such as affordable housing, economic development, immigrant concerns, parks, transportation, crime and protection of our quality of life the county faces some serious challenges. All of this comes together in a budget crunch that is hitting every government and business in the country right now. I feel my background, my current knowledge and willingness to learn and serve will help the council tackle these tough issues with respect and concern for those involved."

#### Joe McDermott

"I am well aware of the challenges King County faces and have unique experience to bring in finding solutions. The 6 years I spent working in the Pierce County Prosecuting Attorney's office gave me great insight into the criminal justice system. With criminal justice services

making up approximately 70 percent of King County's general fund budget, knowledge of programs successful in not only saving money but producing positive outcomes, such as drug court, mental health court, and family court, will serve me well. My 4 years as a Senior Budget Analyst for the Seattle School District allowed me to work with principals and program managers across the district to develop responsible budgets for individual programs and the school district as a whole. This work experience is underscored by my service on the House Appropriations Committee and the Senate Ways & Means Committee, where I have made valuable contributions towards responsible budgets.

"While the structural budget gap will continue to be a key issue for King County, other immediate concerns include addressing the potential flooding of the Green River until the Howard Hanson Dam is fully repaired, completing the tunnels servicing the Brightwater sewage treatment plant, and Metro Transit's budget shortfall. In my career in public service I have always taken up complex issues such as these and brought people together to solutions."

#### Sharon Nelson

From 8 yrs as Council staff and 2 yrs as state rep, "I know first hand the challenges facing our district and region in issues such as transportation, land use, and the County's structural budget gap."

# Knowledge of the issues affecting the constituents of Council District 8

## Jan Drago

"Residents of Council District Eight face unique transportation challenges, especially during the construction of the Alaskan Way Viaduct project. lied the Seattle City Council to prioritize and find full funding for the South Spokane Street Viaduct project so it would be completed before the construction of the AWV project. I have also been a strong advocate for water transit, including the West Seattle Water Taxi and the Vashon Island ferry. District Eight also includes the Duwamish industrial manufacturing area where there are many challenging issues including transportation and job retention and expansion."

### Zack Hudgins

Did not refer to issues affecting the constituents of Council District 8, as opposed to King County in general.

### Joe McDermott

"While King County faces many challenges, District 8 also faces specific issues. In the coming year, the Council will review the Shorelines Master Plan, which is critical to District 8 and Vashon and Maury Islands as over half of the undeveloped shorelines in King County are within this district. My personal knowledge of the unique value of this shoreline developed over the last 9 years representing the 34th District in Olympia and will contribute to meaningful review in 2010.

"The South Park Bridge is at risk for closure in 2010, with the federal government ranking it at 4 points out of 100 for safety. This vital transportation link carries more than 10 million tons of freight a year and 2,600 trucks daily and serves a high-employment area with approximately 32,000 jobs within one mile. The bridge is a lifeline to a low-income and multi-ethnic community, with 76 percent of businesses in South Park minority owned and 56 percent of South Park residents members of minority groups. Closure would reroute 20,000 vehicles daily onto an already taxed transportation system. I championed efforts to secure federal TIGER Stimulus funds for this essential project and would bring this advocacy to the Council.

"When Washington State Ferries could no longer support passenger-only ferry service, I worked with King County to transfer this service to the county. I am vested in the King County Ferry District's success in linking West Seattle and Vashon with downtown Seattle and in exploring future routes as well."

#### Sharon Nelson

"I know the issues that are important to the district and have already represented the majority of District Eight constituents [as a state legislator]."

## Demonstrated ability to develop responsible budget

#### Jan Drago

"I have served for 16 years on the Seattle City Council Budget Committee, including four years as its chair. During the period of my chairmanship, I worked to make the budget process more transparent and to increase citizen participation through outreach. The current City budget is nearly \$4 billion, including the utilities - Seattle City Light and Seattle Public Utilities. The general fund budget is \$903 million. I have served during three economic down turns as well when the revenues were higher than projected. During the good times we prioritized major maintenance in capital projects and putting money into our stabilization (rainy day) fund to prepare for the economic down turns and funding one time only projects instead of hiring more employees. During the down turns we prioritized funding public safety and human services."

#### Zack Hudgins

"I have served on budget committees each of my seven years in Olympia (Transportation and General Government Appropriations), which means being part of the process for developing and passing a balanced budget."

#### Joe McDermott

"My 4 years as a Senior Budget Analyst for the Seattle School District allowed me to work with principals and program managers across the district to develop responsible budgets for individual programs and the school district as a whole. One example of responding to public concerns was establishing off-leash areas for dogs in Seattle. This issue came from the citizens and was very controversial, facing much opposition from the Parks Board. But I saw this as a problem with a solution. My staff and I worked for three years and involved over 15,000 people before the legislation was passed establishing six pilot areas which later became permanent. Today Seattle has 12 off-leash areas."

#### Zack Hudgins

"My service in the State Legislature, accompanied by the input from all of the meetings, events, town halls, emails, phone calls and letters has taught me about the concerns facing people in a district that was once referred to as the place where American dreams were formed. No matter how you define diversity, it is seen in my community. I represent urban, suburban, and almost rural communities. I reach out to the largest industrial business community in the state where over two billion dollars of payroll a year and 200,000 vehicle trips a day are made in the Duwamish area. There are over 100 languages spoken in the school districts of the 11th, with some schools having free and reduced lunch enrollments passing the 90% mark. I have taken a leadership role working on shoreline issues and super fund clean up sites along the Duwamish river. The 11th includes the King County airfield and the Seattle sex offender confinement facility and numerous other government agencies that affect everyday lives. I reach out and work with as many individuals and groups as I can to provide them with information, help and leadership on the issues they face. I try to answer all the calls that come into my legislative office."
