1 AN ORDINANCE relating to county funds; amending  
 2 Ordinance 17527, Section 162, as amended, and K.C.C.  
 3 4A.200.287, Ordinance 17752, Section 21, and K.C.C.  
 4 4A.200.465 and Ordinance 17527, Section 41, and K.C.C.  
 5 4A.200.500, recodifying K.C.C. 4A.200.287, adding a new  
 6 section to K.C.C. chapter 4A.200 and repealing Ordinance  
 7 17752, Section 11, and K.C.C. 4A.200.295 Ordinance  
 8 17527, Section 161, as amended, and K.C.C. 4A.200.450,  
 9 Ordinance 12076, Section 16, as amended, and K.C.C.  
 10 4A.200.470 and Ordinance 12925, Sections 1 through 7,  
 11 and as amended, and K.C.C. 4A.200.760.

12 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

13 SECTION 1. There is hereby approved and adopted the September 2020  
 14 statement of residual balances of the funds prepared for closure, as presented in  
 15 Attachment A to this ordinance. The transfer of any remaining net assets and fund  
 16 balances upon closure of those county funds repealed by this ordinance is approved and  
 17 adopted.

18 SECTION 2. K.C.C. 4A.200.287, as amended by this ordinance, is hereby  
 19 recodified as a new section in chapter 4A.200.

20            SECTION 3. Ordinance 17527, Section 162, as amended, and K.C.C.

21 4A.200.287 are hereby amended to read as follows:

22            A. There is hereby created the fleet services equipment rental and revolving fund.

23            B. The fund is a first tier fund. The fund is an internal service fund.

24            C. The director of the department of executive services shall be the manager of  
25 the fund.

26            D. All receipts from rates charged for full cost recovery for the fund's services to  
27 county agencies shall be deposited in the fund. The department of executive services  
28 shall establish charges for full-cost recovery for the equipment accounted for by the fund  
29 and shall establish the terms and charges for the sale of surplus equipment.

30            E. The fund shall be used for the purchase, maintenance, and repair of county  
31 equipment, for the purchase of equipment, materials, supplies and services required in the  
32 administration and operation of the fund, and for the purchase or manufacture of  
33 materials and supplies needed by county departments using fleet services equipment.

34            SECTION 4. Ordinance 17752, Section 21, and K.C.C. 4A.200.465 are hereby  
35 amended to read as follows:

36            A. There is hereby created the open space and farmland acquisition fund.

37            B. The fund is a first tier fund. It is a capital projects fund.

38            C. The director of the department of natural resources and parks shall be the  
39 manager of the fund.

40            D. All moneys for the acquisiton of open space (~~(acquistions)~~) or farmland in fee  
41 title or by easements, for the acquisition of agricultural development rights and for  
42 improvements on agricultural land owned by the county, shall be deposited in the fund.

43 E. All moneys in the fund shall be used for the purpose of paying all or any part  
44 of capital projects related to acquiring open space or ~~((open space))~~ farmland, in fee title  
45 or by easements, acquiring agricultural development rights or making improvements on  
46 agricultural land owned by the county.

47 SECTION 5. Ordinance 17527, Section 41, and K.C.C. 4A.200.500 are hereby  
48 amended as follows:

49 A. There is hereby created the parks, recreation and open space fund.

50 B. The fund shall be a first tier fund. It is a capital projects fund.

51 C. The director of the department of natural resources and parks shall be the  
52 manager of the fund.

53 D. The fund's revenue sources may include, but are not limited to, proceeds from  
54 real estate excise taxes, grants, bonds and general fund transfers.

55 E. The fund shall provide for the receipt of revenues and disbursement of  
56 expenditures for new park facilities and ~~((nonmajor maintenance enhancements))~~  
57 improvements to existing park facilities.

58 SECTION 6. The following are hereby repealed:

59 A. Ordinance 17752, Section 11, and K.C.C. 4A.200.295;

60 B. Ordinance 17527, Section 161, as amended, and K.C.C. 4A.200.450;



## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, Carahsoft OBO King County ITD (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign, Inc. (DocuSign) electronic signing system. ### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after signing session and, if you elect to create a DocuSign signer account, you may access them for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

### **Withdrawing your consent**

### **Consequences of changing your mind**
